1862-1886.

State Revenues represent the tax imposed upon the citizens of the States of Alabama, California, Louisiana, Oregon and Nevada, by the State Governments, in addition to the regular tax of the United States Government. All are now obsolete.

TO THE STAMP-COLLECTING PUBLIC.

I THINK all collectors will be well repaid for the great delay caused by the compiler of this work in getting out his book, which was advertised to appear in October, 1887, from the fact that the list was originally intended to cover only about two thousand varieties in United States Revenues, while the actual number included up to date (April 3d, 1888.) is four thousand one hundred and ninety-one varieties—more than double the number that it was intended should be included in this edition—and all without extra cost to the public.

It has been a work that required late hours, and few collectors can imagine the amount of labor bestowed and time expended in compiling this, my greatest effort in the catalogue line. If it proves as satisfactory to collectors as my fourth edition, I will feel repaid for the effort.

I have no doubt that errors will be found that I have not noticed, and shall be glad to have them pointed out to me, with a view of correction in my next issue..
