ORIGINAL INDIAN/U.S./MINNESOTA TREATY GIVES RISE TO MINNESOTA'S LATEST STATE REVENUE STAMP

In accordance with the original Chippewa/U.S. Indian treaty and amended by Minn. 1971 Chapter 97 laws and amended by Minn. Resolution 9-73 confirmed by Senate Chapter laws 124, the \$1.00 Leech Lake Reservation (fishing) stamp came into being effective 6/22/73.

This stamp is printed in sheets of 10 stamps and is maroon on bright orange self-adhesive paper. The original order of 300,000 is all that are planned to be issued. Stamps measure 1.4 x 2.1 inches. All 4 sides are straight edge.

On short notice the design of this stamp was assigned to Minn. Dept. of Architecture and was in turn turned over to Norm Holmberg the designer who is the graphic artsman for that department. Only about 8 hours was allocated for the design of this stamp which is short notice for the study of Indian arts etc necessary for the design of the stamp.

After its design was made it was sent to the Leech Lake Band of Chippewas for approval as to design, and then sent to the Department of Natural Resources for final approval.

This stamp is for the collection of additional revenues in addition to the regular Minnesota fishing license for persons fishing in waters of the Leech Lake Reservation. The proceeds of the stamp are to be turned over to the Leech Lake Tribe of Chippewas for conservation of natural resources and wildlife.

It has not been definitely determined as of this time if this stamp is to be used on hunting/trapping licenses of persons also engaging in these activities on the reservation but as of this time it is expected that it will. The members of the Leech Lake band of Chippewas are exempt from paying this additional fee.

Thanks to Norm Holberg, Larry Brown, Joseph Alexander, Don McMann, Don Davidson and many other members of the Minnesota Dept. of Natural Resources and Minnesota Dept. of Architecture for providing the information on this stamp.

1962 Special Grouse Hunting Stamps sodmun

As reported in the original listing the Utah Fish and Game Dept. had stated stamps have never been issued for grouse hunting. However, subsequent research by Kenneth P. Pruess has determined hunters were required to purchase a \$3.00 grouse hunting stamp in 1962 which was valid statewide. 3,179 stamps were sold in 1962. In 1963 hunters were permitted to hunt grouse on a Game Bird or Combination license.

If rationing comes again-St. Charles businessman ready

A reporter never knows where his next story is coming from unless he receives a letter some morning written on stationery from such an unlikely organization as the "Society of Ration Token Collectors."

A title like that should pique the curiosity of any reporter not currently working on anything less intriguing than the Watergate case. It aroused my curiosity.

The letter writer, it developed, was a St. Charles businessman by the name of Jerry Bates. He is presently president of the organization which has fewer than 300 members, who are devoted to the collection of ration coupons and related objects in addition to collecting historical data concerning the same.

BATES HAD BEEN PROMPTED to write
The Globe-Democrat to comment on a story
concerning gasoline rationing during World
War II which had appeared in the paper. He
said the article provided him with information of which he had previously not known.

In addition to gasoline rationing coupons, books and forms, Bates' collection consists of such coupons, tokens and books as were issued by the Office of Price Administration between 1941 and 1946.

He claims his collection of material on U.S. rationing is the largest in existence, seconded only by a collector in Ohio. He also has an extensive collection of rationing material from Germany issued during both World Wars,

And, his collection includes rationing material from England, Canada, Australia, Austria, Italy, Poland, France and India.

Since childhood, Bates said he has been a collector. While no longer interested in coin collecting, he still is interested in collecting Christmas seals, blood donor buttons, wooden money transportation tokens and state sales tax tokens.

HOWEVER, HIS OBSESSION is with what he calls rationing currency. He said the collection of it provides a challenge which is missing in collecting other things such as coins. "When you're collecting coins and need a coin to complete a series, the only way to get it is to buy it," Bates said. "Sometimes this can run into considerable money."

"With ration tokens it's different," Bates explained. "Even a fairly rare token can be bought for as little as 25 cents, but for the really rare tokens you have to go out and find them."

Bates said his collection was the result of endless visits to flea markets and antique dealers, rummeging through miscellanecodds and ends.

He said he has about 1,400 items in his collection, with a potential of about 1,70 items, many of which may have five a more variations or issues.

BATES SAID HE GOT INTO ration toke collecting quite by accident. One day inighbor boy came to him in 1958 with somfiber meat rationing tokens wanting to know what they were for. He said the tokens which he bough from the boy, became the start of his collection.

Originally, Bates said the government is sued meat and processed food stamps in 12, 5 and 8 point denominations. Later, the were issued only in 13 point denomination and the fiber tokens issued in one point denominations for making change.

Red tokens were for meats, fats, fish and cheese, while blue tokens were for processed foods in cans such as canned meat and fruits.

Bates said there were 30 different issue of the red tokens and 24 issues of the blue tokens. He has a complete set of each in hi collection including many which were double struck or have other variations in manufacture.

ALSO IN HIS COLLECTION are specimens of counterfeit ration stamps. There was some counterfeiting of most all types or rationing stamps, but counterfeiters seeme to concentrate on the gasoline rationing coupons. He said there were at least 189 different issues of counterfeit gas rationing stamps.

Bates keeps the wolf from the door and finances his collecting proclivities with hi position with Cloverleaf Properties Inc. He is an officer of the firm which has offices a highway I-70 at the Cave Springs exit at St Charles. The firm is a commercial land developer.

As a side line, he also deals in collectoritems which he is interested in. However, he said he is much more interested in trading and swapping than he is it selling.

The Society of Ration Taken Collectors is a branch of the American Numismatic Association. Bates said his collections have taken 3 first. 8 seconds and 4 third place awards in regional and state shows throughout the nation.

"There is no greater thrill," Bates said "than beating out classic collections, which may have cost the collectors thousands of dollars, with a collection of scraps of pape and fiber tokens to carry off the prize for the best collection of U.S. paper currency."
