GEORGIA ON MY MIND

As have many other states, Georgia has eliminated many of the revenue stamps it once used. Stamps are still required on all distilled spirits but stamps for beer and tobacco products have been eliminated. Similarly, most types of agricultural inspection stamps have been eliminated. Two types of agricultural advertising stamps, however, are still in use. The first is issued by the Georgia Sweet Potato Commission(figure 1). These stamps are sold for l¢ each. The inscription "BUSHEL" and the illustration of the sweet potatos are in brown. A similar stamp is sold by the Georgia Apple Commission for 1/2¢(figure 2). On this stamp the word "BUSHEL" and the apples are in red.



In response to a request by the author for information on current stamps, the state very kindly sent a laminated card showing several of the now obsolete tobacco stamps (illustration, see cover). Many of these are previously unlisted. Going from left to right, the values and colors are as follows:

- 1)20 cigarette heat transfer decal, green and black, red safety.
- 2)8¢ on 5¢(?) red "cigarette tax".
- 3)1/2¢ cigarette tax(this is Hubbard #C45).
- 4)l¢ cigar tax, brown.
- 5)1 1/4¢ cigar tax, pink.
- 6)2¢ cigar tax, green,
- 7)3¢ cigarette tax, green and black, like C65 but no signature.
- 8)3 3/4¢ cigar tax, light blue.
- 9)4¢ cigarette tax, red and black, no signature.
- 10)5¢ cigar tax, yellow.
 11)7 1/2¢ on 27¢(?) cigar tax, pink.
- 12)10¢ cigar tax, olive.
- 13)12 1/2¢ cigar tax, brown.
- 14)15¢ cigar tax, purple.
- 15)18 3/4¢ cigar tax, brown.
- 16)20¢ cigar tax, blue.
- 17)25¢ cigar tax, dark brown.
- 18)37 1/2¢ cigar tax, lawn green.
- 19)50¢ cigar tax, green.
- 20)75¢ cigar tax, lilac.
- 21)\$1.00 cigar tax, orange.



In addition, several additional unlisted Georgia decals have been seen. Specifically: 1)Like Hubbard #C66-68; 5 1/2¢ maroon; 16 1/2¢ deep purple; and 55¢ blue. The signature on these is unreadable. 2)12¢ "BEER TAX" orange. Design like cigar tax decals on card shown on cover(type of #6) but inscription reads "BEER TAX". 3)6¢ "BEER TAX" red on blue, new design(figure 3).

The reverse of the card shown on the cover shows a set of 1961? wine tax decals. Several of these values are not listed in the Georgia addenda published in the March, 1967 NEWSLETTER. The reverse of this card is shown in figure 7. The figures of values are in black on all of these. The colors are: 1 1/4¢ yellow; 2 1/2¢ orange; 3 1/8¢ light blue; 4¢ gray; 5¢ blue; 6 1/4¢ light green; 10¢ brown; 12 1/2¢ rose; 20¢ green; 25¢ orange; 37 1/2¢ red; 40¢ blue; 50¢ green; \$1 red and \$2 blue.

Finally, an unlisted Georgia fertilizer inspection fee stamp is shown in figure 4. This stamp bears Phil Campbell's signature and carries a serial number unlike previously listed issues. The stamp is printed in brown and the first six figures of the serial number are in a darker shade of brown.





SPECIMEN PUNCHES:

The Columbian Bank Note Company printed the state revenues for many states during the 1930s. Apparently the company supplied these stamps with sheets of the printed stamps as samples. These sample sheets are perforated with the words: "SPECIMEN COLUMBIAN BANK NOTE CO CHICAGO". These words covered several stamps, depending on the size of the stamps. This specimen perforation has been seen on the following:

MARSHFIELD, OREGON: Most collectors have probably not seen any of the several values of beverage and wine tax stamps that were issued in 1935. Two different series exist:

Beverage Tax, red or black lettering on grey paper. Values in red are 1/2¢, 1¢, 2 1/2¢, 5¢, 6¢, and 12¢. Only two values were printed in black, 25¢(illustrated) and 50¢.

Wine tax, red or black on white paper. Red values: 1 3/5¢, 2¢ and 24¢. Black values: 3¢ and 6¢.

Several other Oregon cities issued beer and wine stamps during the 1930s and 1940s, including Bend, Klamath Falls, Mt. Angel, North Bend, Portland, Salem, Turner and Umatilla.



WISCONSIN WINE CASE STAMPS

Wisconsin case wine stamps first appeared about 1954. After two sets with values expressed in dollars and cents they were altered to values in gallons in a third tax rate in 1963.

This latter set consists of four stamps--1.5, 2.4, 3.0 and 4.0 gallons, green on greenish paper for "under" 21% alcohol and the same values, red on pink for a short time, then red on yellow for "over" 21% alcohol. These stamps appeared "numbered A to J, bottom to top at left, and K to T at right, rouletted 9 1/4 in black vertically and 6 3/4 colorless horizontally. Binding tab at top is rouletted 3. Position letter in color of stamp, serial number in black.

At first gallons was spelled "Gallons", then "GALLONS" crowded into 17 mm. Finally a neat 19 mm "GALLONS" was arrived at. About 1974 the horizontal rouletting was changed to 4 3/4 and used to the end of these stamps July 1, 1975.

During the life of these stamps three different "Gilbert Bond" water-marks appeared reading up and down. These are:

I. 1" double-lined block letters

II. 1/2" single-lined letters

III. Cap and lower case slanting to right Most stamps in sheet show no watermark.

The 2.4, 3.0 and 4.0 gallon stamps of the 19mm series can be had with all three watermarks. The going is rougher on the always scarce 1.5 gallon stamp.

INDIANA'S AIRPORT HEAD TAX

Only two Indiana cities used the airport head tax system of raising revenue. The first--Fort Wayne at its Baer Field--started collecting the tax on October 1, 1972 and stopped June 18, 1973. The fee charged was \$1.00 and was only paid by those who departed from Fort Wayne. During the period the fee was charged a total of 117,530 of the "boarding passes" were sold bringing that many dollars for the airport authority.

There are only two know varieties of these boarding passes used. Both are a cardboard type ticket rouletted in the center with the left half being a receipt and the right half being the pass itself.

In type 1 the letters "No." and numerals are printed in bright red while the other printing on both sides is in black on a yellow background. There are only five known whole copies of this boarding pass.

Type 2 is similar. The type style and color is the same. However the background is white and the reverse has no printing on it. Both passes measure 101×38 mm.

The other Indiana city using a head tax was Evansville. At the present time nothing is know about the starting date or any other details about its use. However below appears a list of items known to have been used by this city.

The method used to show proof of payment was a peelable label printed on a large sheet measuring 167 mm. across and 178 mm. high. With five duplicate sets of labels all bearing the same number but with different letter combinations. There was also a third set of numbers and letters that was not peelable but was printed on the cardboard sheet. One label was placed on the customers ticket and the other copy was sed by the airline or airport. The used cardboard sheet went to the one who didn't get the second "sticky" copy. It is unclear just which went where in this arrangement. Each little peelable label measured 38 mm. x 29 mm. and was rubber-stamped "EVANSVILLE, IND. \$1.00"



The Editor says:

BOTH WAYS YA' CAN'T HAVE IT!

The officers of the SRS have received several letters of late com- in April what his scheduling will plaining about the lateness of this publication. It is a well-taken observation since the last two issues abandon his paying customers to have been somewhat past the usual month of publication.

So that the entire membership understands how our printing is accomplished, and as an explanation of this seeming problem, the following facts and decisions made by the board of directors(albeit tacitly in some cases) will help clear the situation.

First, it is the belief of most board members that this organization should produce the best journal possible. Given our somewhat tight financial resources(see Treasurer's Report in this issue), the NEWS-LETTER in the past, and hopefully at present, reflects the desire for quality.

Translating this hope into action is something else. Printing is VERY expensive, especially in the small number of copies required for the SRS membership. The use of half-tone photographs multiplies costs geometrically. Even a single sheet, produced by "instant copy" firms, runs \$4/100 for both sides of an $8 \frac{1}{2} \times 11$ sheet. Thus a six sheet(12 sides) corner-stapled item would run \$72 before postage. Photographs using this process are at best of marginal quality; at worst indecipherable.

Our present printing is done gratis by member Dick Bilek(see profile in March, 1976 issue). Dick works our printing among his customer's jobs. In short, his commercial clients are paying the overhead, wages, depreciation on equipment, etc. for publishing our NEWSLETTER. (Anyone living in the Chicago area is invited not to spread the news around). The SRS pays only for mailing and postage.

To print this publication on a commercial basis would bankrupt the organization before 1977. It is asking too much of Dick to insist he adherto a rigid schedule. He cannot tel look like in Mid-May. Furthermore, he has to eat--he cannot print a "freebie".

Aside from mailing and postage (costs we would have anyway) the only additional expense to the membership is the somewhat erratic timing of the NEWSLETTER. If in the future, Dick cannot continue his services the publication will continue. But it will continue under much different circumstances.

Any member unhappy with the late arrival of his NEWSLETTER under the limitations described above is welcome to write any of the officers listed on the masthead and register their feelings.

Obviously we'd all like a top quality journal and a set schedule. But -- BOTH WAYS YA' CAN'T HAVE IT!



The listing of these stamps in Hubbard's Catalog has never satisfied me as I cannot find any perf 13 and have noted differences in the designs of BE-3 and BE-4.

BE-3: Left foot of man at left of seal does not touch ribbon. Upper triangle about 5 mm long at top. 13 short lines to left of left triangle, 12 to right of right triangle. Top of Triangle above line. Perf 11 3/4

BE-4: Top triangle about 3 1/2 mm long and top is in line with the horizontal lines. Il short lines to left of left triangle and 13 to right of right triangle. Left foot of man to left of seal touches ribbon. Deep carmine 5 mm black control numbers perf 11 3/4

- a. double print
- b. rose to carmine shades 3 mm control number
- c. rose perf 12 1/2
 d. carmine perf 11 3/4 x 12 1/2 25 to a sheet, straight edge 4 sides

BE-5: Similar, color parts of cross in seal do not line up. short lines to left of left triangle and ll to right of right triangle. Carmine, perf 12 1/2(I have only seen this with straight edges). Strong dashed lines through "BALTIMORE".

BE-6: Similar design. Arms of cross equal. Both feet of man of left of seal are back from ribbon. 9 short lines to left of left triangle and 10 to right of right triangle. Top of triangles between lines. Carmine perf 11 3/4.

BE-7: The new 22 mm square design is found in fine and coarse prints. Serial number in color of stamp. Rose carmine, Roul. 6 1/2 x 5 1/2.

THE SET OF TOBACCO STAMPS THAT GROWS AND GROWS

The 1957 Mississippi tobacco tax stamps started out as a modest set of about 12 values, 8ϕ to 65ϕ , with hyphen holed perf 63/4. The design was similar to previous perf 12 1/2 stamps. Rising taxes have called for new values from time to time, others becoming obsolete. Only the 10ϕ and 18ϕ of the original values are now in use.

The values are 8¢, 10¢, 12¢, 15¢, 16¢, 17¢, 18¢, 21¢, 22¢, 24¢, 25¢, 26¢, 27¢, 29¢, 30¢, 31¢, 32¢, 33¢, 34¢, 35¢, 36¢, 38¢, 39¢, 40¢, 41¢, 43¢, 45¢, 47¢, 48¢, 50¢, 51¢, 50¢, 65¢, 75¢, 80¢, 84¢, 85¢, 90¢, \$1.09, \$1.19 and \$1.29.

The 41¢ purple and 51¢ dark brown are 1976 issues and make the fortieth and forty-first values. There have been color changes and trials of hyphen hole perfs $5\ 3/4$ and $4/\ 34$ which were not satisfactory but added many varieties.

RHODE ISLAND: The state will now sell its real estate conveyance tax stamps and meters to collectors. The stamps (see illustration) come in seven values. 55¢ light blue; \$1.10 purple; \$2.20 aqua; \$5.50 orange; \$11 dark blue; \$22 olive; \$55 pink. Stamps may be purchased from: Office of the Town Clerk, North Kingstown, Rhode Island 02852. Orders must total at least \$1 and a stamped, self-addressed envelope should be enclosed for return postage. Meters can be purchased from: Office of the City Clerk, City Hall, Providence, Rhode Island. These must be ordered in values that are multiples of \$.55. Again, minimum order is \$1 (actually \$1.10) and return postage is required.
