

## TERRITORY OF GUAM HUNTING LICENSE





## FIRST DAY OF ISSUE

The 1978 Guam hunting stamp was released February 1, 1978 by the Aquatic and Wildlife Resources Division of the Guam Department of Agriculture. This new issue depicts the house gecko, Hemidactylus frenatus, a small species of lizard that is a familiar sight to Island residents as it seems to prefer to live near human habitation. Once considered a sign of good luck when seen inside local houses, the gecko probably served a useful purpose by eating termites and other insects that attacked the roof thatch of homes built by earlier generations of Guamanians. The reinforced concrete homes with screened windows that are being built on Guam today make indoor living a difficult proposition for this useful nocturnal creature but they still may be seen congregating around outside lights in the evening where they patiently wait the insects that are attracted

Mint copies of the 1978 Guam hunting stamp are available for \$5.00 each, cancelled copies are 50¢ each. First day of issue covers franked with a USPS butterfly stamp and cancelled at Agana are available for \$2.50 each. Although all 1977 hunting stamp first day covers have been sold out, a few 1977 hunting stamps are still available at the same price(\$5.00 mint, 50¢ cancelled).

Guam hunting stamps and covers may be purchased at the Department of Agriculture in Mangilao or by writing to: Aquatic and Wildlife Resources Division, Guam Department of Agriculture, P.O. #### CITY OF DES PLAINES VEHICLE LICENSES



As with the other presentations in this series, we welcome additional information or examples of these items.









#### VIRGINIA SLOT MACHINE LICENSES

Member Claude M. Monteiro sends along the two slot machine licenses pictured here. The first is a 1944 Commonwealth of Virginia Slot Machine License which was to be affixed to each machine. The particular one here is for a weighing machine used in Richmond's old Main Street Station. This building is no longer in use. Similar licenses were required for vending machines and "one armed bandits". The \$1.00 sticker was for a 1¢ vendor or 1¢ slot machine. It is thought that a \$5.00 license was required for a 5¢ machine. Mr. Monteiro has be unable to ascertain just when gambling-type slot machines were used but believes they became illegal in the late 1930's or early 1940's.

The second item is an unused City of Richmond license paid which apparently operated under the same general rules as imposed by the state. Each machine in the City of Richmond would be required to have both. It was printed in black on pink paper.

Does anyone else have examples of these licenses or more information regarding their use?

(Editor's Note: .After the above was already pasted up for publication, Mr. Monteiro wrote stating that gambling slot machines were declared illegal in Virginia in 1934).

## IMPORTANT REVENUE LITERATURE REPRINTED, ADDED TO LIBRARY

Thanks to Lou Alfano and the Washington Area Fiscal Society, the library has copies of reprint editions of three important revenue studies. All can be borrowed from the library or purchased from Mr. Alfano, 303 S. Kennedy Road, Sterling VA 22170

- 1. Supplement to Hubbard's 1960 State Revenue Catalog. Price \$3. This includes all the material in Cabot's 1940 catalog which was omitted in the 1960 catalog. Material is conveniently arranged so pages can be inserted into Hubbard's catalog. Included is the specialized listing of early California stamps, illustrations for various stamps, descriptions of the Oregon insurance reprints and counterfeits, Oregon & Washington city beer stamps, Utah private die beer stamps and agricultural marketing stamps.
- 2. Empossed Revenue Stamped Paper News. Vol. 1-5, 1938-1943. Price: \$15. If the price seems high, this is only the original subscription price more than 35 years ago. Over 290 pages with much interesting information on Colonial, Federal and State emobssed revenues(RM numbers in Scott's). No more than 60 complete runs of this journal were ever published and the reprint is complete except for 3 pages. Well worth the price to anyone interested in these stamps.
- 3. U.S. Tax Paid Classics. 99 pages. Price \$7.50. This includes reprints of 3 studies in one volume.
  - a. United States Private Tobacco Proprietary Stamps published in 1909 by Bartlett and Prevost is still the definitive(only?) work on the "tin foil" revenues.
  - b. History of the U.S. Metallic Tax Stamps for Cotton is an illustrated study by Nast written in 1912.
  - c. Handbook and Check List of United States Internal Revenue Stamps, Hydrometers & Lock Seals. Published by Bartlett & Norton in 1912.

## MISSISSIPPI TOBACCOS THAT GLOW IN THE DARK

Last year I noticed some Mississippi Tobacco Tax Stamps were on an unusually white paper and tried my Mineralite(ultra-violet) on them and discovered they glowed with a fright blue florescense due to the chemicals used to whiten the paper.

I have the following values on the florescent paper:

Hypen -hole perf. 6 3/4-10¢, 18¢, 25¢, 27¢, 31¢, 32¢, 34¢, 35¢, 39¢, 40¢(the new ultramarine issue), 45¢, 47¢, 90¢ and \$1.19

Hyphen-hole perf. 5 3/4-18¢, 45¢
Hyphen-hole perf 5 3/4 x 6 3/4-10¢, 18¢, 27¢, 33¢, 38¢, 45¢
and 90¢
Hyphen-hole perf. 6 3/4 x 5 3/4-18¢

A dull white is now used that does not emit any florescence.

FISH & GAME STAMPS AVAILABLE

Kenneth Pruess supplies the following data on available stamps.

ILLINOIS-All duck and salmon stamps are available to collectors at face value plus 25¢ per stamp issuing fee. Duck: 1975, 1976, 1977 (\$5.25 each); Salmon: 1976, 1977(\$2.25 each). A rather unusual requirement is that a separate check be sent for stamps for each year. #### ILLINOIS REAL ESTATE TRANSFER TAX STAMPS

Both meters(SRS NEWSLETTER, January, 1970) and self-adhesive stamps (SRS NEWSLETTER, May, 1970) have been reported being used to collect this tax. I don't believe the stamps have been shown before although Terry Hines reported 15 values have been used. Serial numbers and numerical county codes on all stamps are in black ink. I can supply the colors of the following values:

50¢ red \$4 light blue \$5 purple \$10 brown









Note that the  $50\c$  stamp is smaller than the dollor values. In addition, I have two varieties of the  $50\c$  stamp in my collection. One type has only the county code and serial number printed in black on the basic red stamp. The second type is identical with the exception that the bottom line

50¢ FIFTY 50¢ CENTS

is also printed in black. County code number on all stamps is thought to be alphabetical (Sorry, but I don't know what county 093 represents).

## PENNSYLVANIA BEDDING STAMPS

Charles H. Hermann supplies us with the information that the uncataloged Pennsylvania bedding stamp that appeared on the cover of the March issue is but one of two new designs used in that state.

The pictured item has a large seal and lettering, perfed 12 1/2, on yellow-green safety paper. The other issue has smaller lettering and seal, perf 11 x 12 on plain greem paper.

Mr. Hermann also reports that he has a bedding tag with 8 stamps on it; six on the face-Oklahoma 1¢, Indiana 1 1/2¢, Texas 1¢, a Pennsylvania stamp, Detroit 2¢ and an Ohio stamp with no value. Two on the reverse are a Louisiana 1¢ and a Colorado 2¢.

Can anyone top that?



# 1977 Gun Deer Hunting Units



#### TYPES OF PERMITS AVAILABLE

Unit I - any antlered deer only or any antlerless deer only.

Unit II, subunits - any antlered deer only or any antlerless deer only.

Unit III, subunits A1, A2, B3 - any antlered deer only or any antlerless deer only.

Unit III, subunits B1, B2, C, D, E, F - antlered whitetail only, antlerless whitetail only, antlered mule deer only, or antlerless mule deer only.

Unit VI subunits - antlered whitetail only, antlerless whitetail only, antlered mule deer only, antlerless mule deer only.

A hunter may take only the type of deer described on the permit and must hunt only in the prescribed subunit or unit.

\$3 Resident Small Game. Black on White.

\$7 Resident Deer Gun. Black on White(\$1 Special Uniter Permit required)

\$3 Resident Wild Turkey. Brown on White

\$7 Resident Deer Bow. Black on Buff. \$7 Resident Antelope Bow. Black on Green.

\$3 Resident Fur Bearer. Black on Blue. Resident Antelope Gun. (Not in Stamp Form)

\$35 Nonresident Small Game. Black on White

\$40 Nonresident Small Game with Waterfowl. Black on White.

\$25 Nonresident Deer Bow. Black on Blue

\$50 Nonresident Deer Gun. Red on White(\$1 Special Unit Permit Required).

\$25 Nonresident Antelope Bow. Black on Orange.

The \$1 Special Unit Permit(pictured) is required in North Dakota to hunt deer. The state is divided up by area into 4 units which include 27 subunits Unit I includes 0 subunits; Unit II, 14 subunits; Unit III, 9 subunits; and Unit IV, 4 subunits). Permits are issued for "antlered deer only" or "antlerless deer only" for Units I, II and 3 subunits of Unit III. In the remaining subunits of Unit III and all subunits of Unit IV, permits are issued for "antlered whitetail deer", "antleress whitetail deer", "antlered mule deer", or "antlerless mule deer". For example, the permit pictured here has been issued for Unit IV, subunit DE and is valid for hunting antlered whitetail deer only. These permits can be obtained "used, on license" only and 76 varieties exist.

In the past, expired hunting stamps have been available from the North Dakota Game and Fish Department for a \$1 handling charge. However, according to state law they cannot release these stamps until an audit has been made. This year, the department emphasizes that no audit has been planned for approximately 2 years, so collectors will have to wait before purchasing remainders.

#### MISSISSIPPI TOBACCO

Guess what -- Mississippi has another value in its hyperextended tobacco series. This one is a blue 53¢ item. Also, the 60¢ which has not been used for years and was red-orange has reappeared, but now in greem.







On a vacation to New Orleans last November I found three new soft drink tax stamps for my collection. All are self-adhesive and were used on containers of artificial fruit drink.

- A. Is a 29 mm. diamenter die-cut 1 3/4¢ stamp and was used on a 1/2 gallon jug. It is printed in red on white surface coated paper.
- B. This 32 x 56 mm. die-cut stamp was found on an 8 oz. container. State seal is 15 mm. in diameter. All printing is in black on yellow surface coated paper. Two distinct shades have been found, yellow and yelloworange.
- 6. This specimen is very similar to B. and may not reproduce well. This 40 x 56 mm. die-cut stamp is also printed in black on yellow surface coated paper. State seal in this example is 11.5 mm. in diameter.
