
MICHIGAN BEAR STAMP

CALIFORNIA CIGARETTE TAX - We are told that the initiative petition for repeal of this has failed to quality for the 1960 general election but that the same sponsor is trying again. A total of 262,789 voters' signatures must be obtained by December 12, 1960, before the proposal can be submitted to the 1961 legislature. So, we will have the tax stamps with us for a while yet, at least.

HIGH STATE TAXES - A clipping from one of the local papers from an Associated Press source says that for the first time in history, every man, woman, and child in the nation paid average state taxes of more than \$100 during the year ended June 30th 1960.

KENTUCKY CIGARETTE TAX we understand was reduced by H. B. 75, laws 1960, from 3¢ per pack to 212%.

FRED. E. CARVER was awarded a gold medal on his Washington apple tax stamps as well as a bronze medal for his topical collection of fruit on stamps at the recent A. P. S. show in Portland. Mrs. Carver also took a silver medal for plating of savings bank issue of China. Congratulations.

DECAL REVENUE STAMPS

By Elbert S. A. Hubbard

THE DECAL STAMP is one type of stamp which our Federal Government has never attempted to use, although our states have used them extensively on many different products, primarily liquor and cigarettes.

These fragile stamps are made up of several coats of lacquer printed on the gummed side of heavy paper by a silk screen process. The screen is made photographically from a multiple subject negative produced from the master drawing.

The decals are very hard to collect in used condition, often cracking into pieces when soaked (a long process) from the container. They should be mounted in Visi-Trays, or similar mounts, for preservation. Some collectors blot most of the moisture off and put them on gummed paper, after soaking them off.

Cur personal preference is to collect them mint as far as possible and 'mount' them in crystal clear black stock sheets with acetate covers over the entire face. This way they may be rearranged many times with very little trouble when new items show up. The only difficulty is that the stock book must be handled with care to prevent their shifting around -- and never, never, make the mistake of putting it away upside down, or <u>dropping</u> it upside down, or on a side!

The relative ease of making a silk screen reproduction of the decal stamp is undoubtedly the deterrant to the Federal Government using this type of stamp. Many states have had trouble with decal counterfeits, among them, Illinois and Missouri liquor stamps and Texas cigarette. Oddly enough the Texas counterfeit was printed on thin paper instead of being made in decal form:

OHIO BEDDING AND UPHOLSTERY - Two paper stamps which we cannot illustrate on account of their color. Square stamps, about 21 mm each way, a design similar to the one shown in Hubbards catalog, with the word "Stamp" below seal and "Department of Industrial Relations" in panel at bottom with value beyond the panel in each lower corner of the stamp. Inscribed "BEDDING • UPHOLSTERY" instead of "BEDDING STAMP." Perforated 122.

OHIO CIGARETTE TAX - Another decal in the design of the first issue paper stamps, reduced in size to about $ll \ge x \ l4 \ mm$. Our copy is a used one and we can tell is was on safety card but do not know the color or separation details.

3¢ green

OHIO LIQUOR SEALS - Three designs, one of which is shown. All are decals - used copies, so we cannot give the details of the card on which they come.

No Value - Red on white (illustrated) No Value - Blue on white (like illustration but no cross hatching in number panel No Value - Blue on yellow (similar



design but 23mm wide by 19mm high, "Department of Liquor Control" in one line, plain number panel (without cross hatching)

OHIO WINE AND MIXED BEVERAGE TAX - A new design, especially in the frames of the figures, and on grayish safety paper with diagonal bars instead of the familiar "OHIO" paper. Perforated 12. With 1959 punched dated cancel.

36¢ orange red ARKANSAS HONEY TAX I have the small stamps in new colors, both with red roulette just under 7. 1 lb. green 2 lb. violet PENNSYLVANIA CIGARETTE Decal on gray safety card, black rouletted 62.
