CURRENT CALIFORNIA DEPARTMENT OF MOTOR VEHICLES INFORMATION FEE STAMPS

Certain specific types of information regarding licensed California drivers and motor vehicles registered in California are available to the public from the California Department of Motor Vehicles upon payment of a specific fee which can be paid by affixing specially printed Information Fee stamps to specially printed forms used to request such data. Four different Information Fee stamps are currently in use; 25¢ pink, dark blue design; 50¢ yellow, black design; 75¢ blue, black design and \$1 green, black design. A set of these stamps is shown in figure 1.

The designs of the two lower values differ slightly from those of the 25¢ and 50¢ stamps reported in the November, 1973 NEWSLETTER (page 79). The differences are most noticeable in the shape of the denominations. On all four values the first five digits of the serial number are printed in black in a separate printing operation. The final digit of the serial number is in the same color as the design (as is the initial serial letter) and is printed in a different typeface.

Figure 2 shows a complete pane of 10 of the 25¢ value. This shows the location of each final digit in the pane. Shading differences on the first and second stamps in the pane in the "¢" character can be seen on this pane. These differences seem to be consistent over different panes of the 25¢ denomination, but other values show no such differences. All values are imperforate, with pressure sensitive gum. A table giving the costs of the various types of information appears below.

STATE STAMPS AT FACE VALUE

Collectors know that many states require rather large minimum purchases before they will sell their stamps. California is a case in point. The Department of Motor Vehicles currently issues four values of Information Fee stamps. A set has a face value of \$2.50 (see accompanying story for details). The DMV imposes a minimum purchase of a pane of 10 stamps. Thus, to get a complete set a collector would have to pay \$25.00 for a pane of 10 of each value. Few are likely to do so. As a service to its members, the State Revenue Society has purchased 20 complete sets and is offering them to SRS members at face value (\$2.50) plus a stamped, addressed envelope.

Orders should be addressed to SRS President Terence Hines, Neurology Department, Cornell Medical College, 525 East 68th Street, New York, NY 10021. Make checks payable to the State Revenue Society. There is a limit of two sets per member.

This offer is really an experiment. If there is enough response the stamps of other states will be offered in the future. Any suggestions for future offerings will be most welcome.

MUNICIPALS OF PUERTO RICO

Information on the municipal revenue stamps of Puerto Rico is sparse. The stamps were listed in the 1905 and 1909 editions of the Forbin catalogue but were dropped in the 1915 edition. A few lines were also devoted to the municipals in the serialized article on Puerto Rican tax stamps compiled by John Bobo for The American Revenuer (March, April and May, 1968). To the Forbin and Bobo date I have been able to add a few bits and pieces of information from my personal collection.



According to Forbin, the municipal governments of Arecibo, Guayama, Mayaguez and San Juan issued their first revenue stamps, under the U.S. administration, in 1902. All four of the local governments choose the strip stamp format that the central government had adopted the year before (Figure 1).

The stamps of Arecibo are the shortest of the lot, measuring only 59 x 10 mm. The denomination is in the center with "IMPUESTO MUNICIPAL" inscribed on the left of the stamp and "ARECIBO, PTO. RICO, US" on the right. The set consists of four values: 1/4¢ red, 1/2¢ blue, 3/4¢ brown and 1¢ violet. The design varies somewhat from denomination to denomination. Each of the stamps is perf. 11 horizontally.



Guayama and San Juan apparently only issued one stamp apiece during this period. The Guayama stamp (Figure 2) is orange and measures 125 x 9 mm. The stamp is unwatermarked and is perf. 11.

The San Juan stamp has no denomination. The stamp features the seal of the United States on the right and left sides, along with the word "PAGADO". The center carries the inscription "IMPUESTO / SAN JUAN PUERTO-RICO / MUNICIPAL". The stamp is blue, measures 117 x 11 mm. and is perf. 11 1/2.

While Guayama, Arecibo and San Juan chose to issue all-purpose stamps, Mayaguez chose the other approach and specified on each stamp what tax it was to be used for. The following stamps are known: 5/8¢ (cigarettes, Figure 3), 3/4¢ (Beer, Figure 4), 3¢ (alcohol), 3¢ (whiskey) and 6¢ (brandy). The stamps are light blue, green, green, black and orange, respectively. Forbin also lists a \$1.25 stamp and a \$1.37 1/2 stamp but gives no indication as to color or purpose. With the exception of the 5/8¢ cigarette stamp, each of the stamps measures 123 x 42 mm. and are imperforate. The 5/8¢ stamp measures 117 x 12 mm. and is perforated 11 1/2 horizontally.

No further municipal tax stamps appear to have been issued until the early 1930's. Sometime in the early '30's, according to John Bobo, San Juan issued a set of high value revenues (Figure 5). The set consists of the following denominations: \$5 (black), \$10 (pink), \$20 (brown) and \$50 (light brown). The denominations are in red. The \$20 stamp, however, is also known to exist entirely in black. The stamps are rouletted 13 1/2 and measure 40 x 31 mm.

Many SRS members also collect postage stamps and receive Linn's Stamp News. They may have noticed, then, that in the June 18 issue Linn's carried an article reporting that the Federal Trade Commission had sent warning letters to 12 stamp companies that the Commission felt engaged in practices that did not make it clear to customers that unsolicited approvals need not be paid for nor returned, but may be considered a gift. The FTC's letter pointed out that if firms continue to engage in unfair or deceptive practices, they would face fines of \$10,000 per violation. The Linn's story had one curious omission: the names of the firms warned appeared nowhere in the story. Most curious! I will leave speculation regarding Linn's dedication to fully informing their subscribers versus protecting their advertisers to the reader. Just to set the record straight, the firms warned were the following:

The March 31, 1979 issue of the Philatelic Literature Review contains two articles of interest to SRS members. Both are bibliographies prepared by Elliot C. Chabot.

CHARLES H. HERMANN

Charles(Charlie) H. Hermann died sometime between the night of May 31 and the morning of June 2 at his home in Tujunga, California. Charlie was an Honorary Life Member of both the State Revenue Society and the American Revenue Association. He was one of the most prolific writers on state revenues. In addition to his innumerable contributions to the NEWSLETTER, he wrote a regular state revenue column for Linn's. Just before his death, Charlie was named to the Edward Boker Sterling Memorial Roll of Distinguished Fiscalists, a new American Revenue Association award that honors the most distinguished revenueurs.

But simply listing all of Charlies' honors gives no real feeling of what a fine person he was. Charlie was always willing to share his absolutely encyclopedic knowledge of state revenues with fellow collectors, new and old. Anyone who write him with a question got a complete response, often including several pages of listings from Charlie's collection. I doubt that his full contribution to revenue collecting will ever really be known. We will all miss him greatly.

This knowledge he freely shared with(along with his duplicates) collectors all over the U.S. He was an avid trader and corresponded with many who he had never met. He was an active mineral collector and made field trips this year.

He was a gentleman in the finest sense of the word. He practiced being one in all his actions and I never heard him make an unkind remark or take advantage of anyone. He had all the virtues to which most of us aspire. I for one am richer for having known him.

Our hobby has suffered the loss of an outstanding man and a good friend. I know that I will miss his amused smile and quick wit.

In recent years there have been several single state catalogs printed but the last major catalog for all states was written in 1940 with a revision in 1960 by Hubbard and many others who were not named in the catalog.

Revisions of every state are now needed. It is felt that by making the catalog available through The American Revenuer many problems can be overcome and the catalog will receive the wide distribution needed so that it will become the standard state catalog. There will also be public distribution of the catalog.
