#### EXPERIMENTAL NEW YORK CITY-STATE CIGARETTE TAX DECAL

The illustrated cigarette tax decal is an experimental issue that was used only by a single distributor in New York City for a period of eight weeks from March 14 to May 6, 1983. The decal is blue with black serial numbers. The numbers read either from left to right(as illustrated) or right to left. The stamp apparently paid two different tax rates. On April 1, 1983 the combined New York City-State Cigarette tax was increased from 23¢ per pack of 20 cigarettes to 29¢ per pack of 20.



According to Mr. George Abatto of the New York State Department of Taxation and Finance, the stamps were produced "by a firm that is new to the field of producing cigarette tax indicia". Also tested with the stamps was equipment used to affix the stamps. "The test period was sufficient to determine that the machinery worked satisfactorily. Its use was discontinued because we are under contract, which resulted from competitive bid, with another manufacture of cigarette tax indicia" said Mr. Abatto.

No inidcation was given of how many of these stamps were actually used. Considering the short period of use and the employment of only a single distributor, these experimental decals will be quite rare.

#### SOME ADDITIONAL STATE DUCK STAMP OBSERVATIONS

The following are some additional notes on data which has appeared in the NEWSLETTER and elsewhere concerning State Duck stamps.

SOUTH DAKOTA: Bennett County Canada Goose hunting stamps were first issued in 1974. Year 1974 through 1977 stamps were free to land owners of Bennett County. A limited number of stamps were issued to other South Dakota resident hunters on a computerized drawing basis. The 1978 stamp show "FREE" printed on the face but a \$5.00 charge was made for each. Bennett County stamps were discontinued after 1978 and replaced with the \$2.00 West River Unit Canada Goose stamps which included three more counties(Haakon, Jackson and Pennington). All four counties were rubber stamped in purple to indicate county of validity. A fifth county(Perkins) was added to the unit in 1980 and was rubber stamped in purple. All 1979 and 1980 stamps were \$2.00 face and featured the same flying goose design as prior issues. The 1981 \$2.00 issue were printed text without design and the stamp title was changed to "Prairie Canada Geese". Rubber stamps were used to indicate county of validity as with prior issues.

Non-Resident Waterfowl stamps were not issued from 1970 through 1976 only but have continued each year to date. These were \$30.00 face. The 1982 stamps are \$50.00 face.

South Dakota has never issued a stamp titled "Pheasant Habitat" although "Pheasant Restoration" stamps have been issued in 1977 to date. The license officer has advised these stamps had no connection whatsoever with the 1976, 1977 or 1978 resident duck stamps but were required by all hunters for pheasants, quail, partridge, grouse, rabbit, tree squirels, etc. as well as waterfowl and are no more a duck stamp than they are a squirrel stamp or rabbit stamp. They certainly are not duck stamps per se, and in my estimation do not belong in a waterfowl collection or check list.

The Lower Brule Sioux Tribe Migratory waterfowl listing should state that this stamp was first issued for 1962-63 season and the same "blank for date" stamp was used through the 1969-70 season and probably later.

NORTH DAKOTA: Non-Resident Waterfowl stamps have been issued from 1975 through 1981 at a \$5.00 face. The 1982 stamp has been increased to an \$8.00 face. North Dakota has issued a \$9.00 Small Game and Habitat stamp portraying Canada Geese for 1982. According to telephone calls to Mr. Dale Henegar, Director and Mrs. Lucille Gohring, license clerk at the Bismarck office, this stamp is required to hunt all small game including pheasants, partridge, grouse, mourning doves, tree squirrels, sandhill cranes and waterfowl. Some stamp dealers and print ventors are representing this as a "duck stamp".

MICHIGAN: A recent report indicated a 1977 Duck stamp with no perforations. As regularly issued this stamp came in panes of 10 (2 x 5) with a roulette gauge of approximately 3 between stamps. On many stamps the tiny paper tabs left between ends of the rouletting are barely visible to the naked eye.

MASSACHUSETTS: The state requires that all artists competing in the annual stamp contest submit an entry depicting a profile view of a "working decoy" created by a deceased Massachusetts docoy maker. The makers whose names appear on these stamps are all"long dead". It is interesting that the 1980 Old Squaw decoy by Holmes wasn't carved but was constructed of slats and canvas, and that the 1979 and 1982 stamps portray shore birds instead of waterfowl. A "working decoy" is one which was actually used for hunting as differentiated from the decorative art types now produced by so many contemporary carvers.

MARYLAND: All Maryland ducks are split year and should be listed as such. The 1981-82 stamp portrays a single drake widgeon--not a pair.

ILLINOIS: In error the first printing of the 1981-82 stamps depicting a pair of Widgeon was erroneously labelled "GREEN WINGED TEAL". Before departmental knowledge of theerror surfaced 274 of these stamps were sold to the general public. An additional 1500 error stamps were given to Ducks Unlimited to sell in a fund-raising effort.

CALIFORNIA: There were not two duck stamps issued for the 1977-78 season. The \$1.00 stamp was valid 7/1/77 through 6/30/78. In mid-season the legislature increased the fee to \$5.00 effective January 1, 1978. The \$5.00 stamp was valid for only the 1/1/78 through 6/30/78 period. Hunters who had purchased the \$1.00 stamp on, or before, 12/31-77 were not required to buy the \$5.00 stamp and were allowed to finish out the 1977-78 season with the original \$1.00 stamp. Paul B. Johnson illustrated all the California stamps until the 1978-79 issue.

Although none has ever been know to have been issued or used, completely imperforate stamps of the following years do exist:

- a. 1979-80 \$5.00 Pairs and blocks from sheets
- b. 1979-80 \$5.00 Vertical booklet panes of 5 with tab at top.
- c. 1980-81 \$5.00 Partial serial numbers-pairs and blocks from sheets
- d. 1980-81 \$5.00 No serial number-pairs and blocks from sheets

The writer is in agreement with the concensus opinion of several knowledgeable collectors that these are almost certainly printers waste rescued from the usual destruction fate of most such stamps.

California Honey Lake Migratory Waterfowl stamps issued 1974-1977 \$15.00 face apparently include departmental insignia on the face of the stamp. This writer has never seen or heard of these stamps with any type of departmental insignia on it. An inspection of such is solicited by this writer.

IOWA: Completely imperforate Ducks(probably printers waste) exist for the following years: 1972, 1973 and 1975.

MONTANA: Has never issued a duck stamp as such. The 1969-70 and all to date issues of the resident, youth and non-resident Bird Hunting stamps were required to hunt all game birds. The 1980-81 "Bird Art Stamp" was only a label sold at \$2.00 to collectors. Printing on the face of the stamp itself states "this stamp is not a hunting license". Montana has not discontinued their Bird Hunting stamps as of the 1982-83 season.

TENNESSEE: All Tennessee Duck stamps are split year. The 1982-83 stamp is \$6.00 plus 59¢ issuing fee.

FLORIDA: All Florida Duck stamps are split year. The 1979-80 stamp depicts a pair of Green-winged Teal.

OHIO: Although the title "Wetlands Habitat Stamp" is confusing, Ohio issued a 1982 stamp at \$5.75 face required to hunt ducks, geese and brant which is valid until 8/31/83. The cost of the stamp includes a 75¢ agent's fee. The Department of Natural Resources at Columbus advises this stamp is required to hunt only the waterfowl listed above and nothing else so it should definitely be considered a duck stamp.

#### GERALD M. ABRAMS

Gerald M. Abrams, President of the American Revenue Assocation and member of the SRS Board of Directors died after a long and heroic battle with cancer on April 9, 1983.

I had never met Gerry, something I will always regret, but we had corresponded for many years and had spoken on the phone often. It gives some sense of Gerry's dedication that during the final stages of his disease, when he could not write and had to dictate his letters to his sister, he continued to send me items he thought would be useful.

During the years of our correspondence, I think I grew to know Gerry quite well. We often did not agree and Gerry was no stranger to controversy. Through these disagreements with other revenuers, however, it was clear that Gerry was motivated by a real concern for the ARA. He could be contentious and stubborn, even maddening(in short, he was human), but through it all his dedication to the ARA was clear.

He contributed more to revenue philately than any other modern collector. He transformed the ARA from an "unknown society" into one of the most respected philatelic specialty societies in the world. He helped make revenue collecting what it is today.

He will be greatly missed.

#### MISCELLANEOUS NOTES

Recent purchase of a collection of state liquor stamps revealed the following unlisted varieties.



INDIANA. The illustrated stamp doesn't exactly fit any of the descriptions in the Indiana addenda (SRS NEWSLETTER #69, May, 1967). It is a 1/5 gallon denomination in brown on cream safety card. The serial number is 4 1/2 mm. wide and reads down. The serial number panel is 6 1/2 x 22 mm.

MINNESOTA. Wine & liquor decal, 1944 re-engraved set, new value-12 1/2¢ black on deep pink.

MISSOURI. Liquor tax, 1947 with Burke-Morris signature, new value-1¢ grey.

OHIO. B71 imperforate.

OHIO. Liquor seal like LS13(in addenda), but perf. 11.


TEXAS. L59 on white safety card.

GEORGIA: Liquor decals. Like 1941 set illustrated in Hubbard (#s L11-L15), but without any signature. Values seen are 6 1/4¢ black and blue and 12 1/2¢ green and black. On cream safety card.




PENNSYLVANIA. Unlisted liquor seal is illustrated. This is black and blue with black serial number on cream safety card, clear roulette 6 1/2.

TENNESSEE. 1939 liquor decal (Hubbard L3) 8 3/4¢ blue has been found on rose card, not the usual white card.

### CIGARETTE TAX CHANGES NOTED

Harold A. Effner, Jr. notes two important increases in cigarette tax rates. First, Massachusetts smokers will be paying 26¢ each pack instead of 21¢. Retailers in the Bay State noted little stockpiling by customers in the face of the change.

New Jersey has tied its cigarette tax rate to the wholesale price of smokes with new legislation. A new law provides for the cigarette tax to equal 6% of the wholesale price and stipulates that a new rate can be set every six months without passing an additional law through the legislature.

Thus when manufacturers upped their prices this June the boost triggered a l¢ rise in the cigarette tax effective July 1st.

This increase brought the state tax to 25¢ per pack. State officials estimate that the 1 cent increase will yield about \$8.4 million during fiscal 1984.

Member Dick Bilek passes along the information that all year 1982 and prior stamps issued by the State of Maine for salmon and pheasant hunting have been reduced to \$1.00 each. This includes both resident and non-resident issues.
