NEW MISSISSIPPI STAMP

Mississippi taxes cigarettes, cigars, smoking tobacco and snuff and chewing tobacco at a percentage of retail price and at different percentages therefor. Thus, to provide denominations for use singly(to save labor) on packs and boxes, new denominations and new colors of old denominations are usually necessary after each session of the legislature.

Apparently, about 1954 the rates set were such that the general tobacco series did not contain all denominations necessary for use on the commonly used packages of snuff and chewing tobacco. Therefore, tobacco stamps with the additional inscription "snuff and chewing" over the state seal were issued in 8, 12, 15, 18, 30 and 60 cent denominations. Also, the and 30 cent denominations were added to the general tobacco series soon afterwards and the corresponding denominations in the snuff and chewing tobacco series were retired before many were used.



The 12 through 60 cent denominations (T108-T112) were listed in the Mississippi Addenda to the 1960 State Revenue Catalog (1968). Only one copy is know of the 30 cent; therefore, it was unpriced. The other denominations were priced at \$1 each, which indicates that they are not scarce.

I am now pleased to report and illustrate the only copy known(according to the late Charles H. Hermann) of the 8 cent Mississippi Snuff and Chewing Tobacco stamp, slot perforated 6.5, dark blue. Insert it in your Mississippi Addenda as number T107A.

THE BRUNDAGE COLLECTION OF LOCAL REVENUE STAMPS

The major printer of local revenue stamps since at least the early 1960s has been Donald Brundage of Atlanta, Georgia. These stamps have generally been decals, although a few pressure sensitive stamps have also been printed. I have recently purchased Mr. Brundage's collection of the samples and remainders of the stamps he has printed. While the collection does not include examples of each and every stamp printed by Brundage, it is extremely extensive and includes hundreds of previously unrecorded issues. Also included are proofs. The contents of this collection are described in this article. Stamps are grouped alphabetically by state and organized alphabetically by town, city or county name within states. At the end of the listing is a group of stamps that could not be assigned to any one specific state. Also included in the listing are a few stamps that were not printed by Brundage. These were apparently sent to him by new customers to indicate the general type of stamp they had used in the past. Most of these appear to have been printed by the American Decalomania Company of Chicago.

Other articles on local stamps have appeared. In the September, 1970 issue of the <u>Newsletter</u> (Vol. 10, # 5, whole # 90) Hines covered Georgia local beer tax stamps. In the May, 1973 <u>Newsletter</u> (Vol. 13, # 3, whole # 106)Bellinghausen and Pruess covered Alabama local tobacco stamps. The listing in the present article will duplicate some of the material in these previous articles. However, the present article presents specific information on the design of all stamps listed. This information was often missing in the previous two articles.

The vast majority of these stamps are of the familiar tobacco leaf design, differing only in the inscription indicating the type of tax and the name of the city, town, or county. Figure 1 shows three versions of this design with different inscriptions for cigarette, cigar, and tobacco tax. These inscriptions are indicated in the listing. Stamps of this general design may vary slightly from one governmental entity to another in the exact type face used for the inscriptions and the nature of the value numeral. Stamps with designs other than the tobacco leaf type are individually illustrated.

Quite a few stamps were printed over a period of years and color variations appeared during the various printings. These differences are, for some reason, especially large for the blue stamps. Such varieties are noted by the word "shades" following the color. In those cases where the shades

Occasionally too much ink was applied to the printing plates and some of the smaller lettering was rendered almost or totally unreadable. Such instances are noted in the listing. Often this problem was corrected in later printings resulting in two distinct varieties of the stamp. Such varieties are noted in the listing.


