

"GUIDE LINES" ON NEVADA DOCUMENTARIES



Frederick E. Heyden wrote an article for the American Philatelist back in 1920 which said, in part, "I know of no stamps showing a wider variation in color than the 2 cents and 50 cents Nevada state revenues." There can be little disagreement with that statement. Now more than a century has passed since these issues were in use. Those that remain extant are starting to show their age. Some of the ink pigments are changing color due to oxidation while others are fading. Some of the paper the stamps were printed on is now showing discoloration.

As collectors know, these stamps were printed in a wide range of yellows, various shades of orange and red orange. However, also listed are two 2¢ Nevada "double star" rouletted 10 stamps described as being "dull brown orange" and "bright brownish orange." It is on these two stamps that this article is centered.

To the new collector of these Nevada revenues it is difficult at times to determine what is considered dull brown orange as opposed to bright brown orange, especially if good specimens of each stamp are not available for comparison. A good approach is to carefully inspect these brownish stamps with a magnifying glass. The dull brown orange stamp should have a very faint printed guide line centered in the gutter between the rows of stamps. These lines run both vertically and

horizontally. The bright brownish orange stamps do not show this guide line and have perfectly clear gutters between the rows. While there may be some disagreement among collectors as to which of these brown orange stamps is "bright" and which is "dull," there should not be any disagreement that, for indetifying purposes, one stamp has the guide lines (Figure 1) while the other does not (Figure 2).





This story would not be complete without a brief review of the \$1.00 Nevada rouletted stamps. One of these dollar issues is listed in catalogs as being carmine rose with "outer line." The words "outer line" may be somewhat of a misnomer as the description would suggest that the stamps should look similar to the one listed as being an imperforate 2¢ orange single star stamp with "retouched heavy outer line." The 2¢ single star stamp does indeed have a heavy border line around the engraved design, but the \$1.00 carmine rose stamp definitely has gutter guide lines similar to the 2¢ dull brown orange stamp referred to above. This same \$1.00 stamp may also include a very faintly printed border line around the engraving (Figure 3). However, inspection of some of these stamps reveals no border line, perhaps caused by use of a worn plate. Catalogs also list another \$1.00 value stamp as "without outer line" and specimens viewed show no trace of a border line around the design (Figure 4).

Why would only two of the Nevada stamps have guide lines? Perhaps the answer lies in the fact that there were a number of printings of these issues. Button & Co., Britton & Rey, Valentine & Francis and A. L. Bancroft Co., all of San Francisco, are variously named as printers of the Nevada documentary revenues. No one is really sure who did which printings as there are no imprints on the sheet margins. Possibly one of the printers, upon receiving an order for a supply of 2¢ brown orange and \$1.00 carmine rose stamps decided to engrave guide lines on the plates between the rows of stamps to enable more precise rouletting.

It should be noted that the rouletting and guide lines on the illustrated stamps have been enhanced for illustration purposes. All illustrations in this article are enlarged 100%.



The "VERMONT / GRADE A" and "Supervised by / COMMISSIONER OF AGRICULTURE / EDWARD H. JONES / MONTPELIER" is in red. Presumably, this same label was used for various grades of eggs in the six New England states with the specific grade and the name of the appropriate official printed in red. When were these used? The only clue is that Edward Jones was Vermont Commissioner of Agriculture from 1924 to 1944. Further information on this clearly private label is solicited!

#### NORTH CAROLINA HUNTING AND FISHING STAMPS

The North Carolina Wildlife Resources Commission in Raleigh regulates hunting and fishing in North Carolina. In each of the 100 counties there are generally several bonded license agents that are permitted to sell state hunting and fishing licenses. The agents are usually sporting goods stores, hardware stores and the like.

In past years the sportsman was required to carry an individual license for each privilege that was granted. In many cases this meant carrying three, four or more different licenses. A "sportsman's license," introduced in 1974, helped cut down on this excess paperwork. However, with more and more people taking part in outdoor activities and the list of potential licenses growing, an additional change was needed. What probably tipped the scales in favor of the stamp program that was introduced in the 1983-1984 season was the apparent success of such programs in other states and the hopes that the program would rise additional monies for the wildlife program.

The season beginning July 1, 1983 saw the implementation of the stamp program. At this time the expiration date of all dated licenses was changed to June 30. There were three basic types of licenses in North Carolina: annual, short-term and lifetime. Only the lifetime licenses remained unchanged under the stamp program. When the program was introduced two different heavy paper trifold passbooks were issued. Figure 1 shows the front (top) and back (bottom) of two different 1983-1984 resident passbooks. The front shows the unusual usage of

four different stamps with a total face value of \$32. For only \$30 the bearer could have purchased a sportsman's license stamp and had additional privileges. Usage of such a stamp, on the back of a different license, is shown at the bottom of Figure 1. Another, similar, passbook was used for nonresident licenses. Stamps for various license privileges were to be attached, as needed, to these passbooks.

Three pictorial stamps were issued for the 1983-84 season, a resident and nonresident sportsman stamp, which granted all hunting and fishing privileges in the state, and a voluntary waterfowl stamp. Additional information on these stamps has appeared in the Jan.-Feb./March-April, 1984 State Revenue Newsletter (Vol. 23, #s 1&2), page 6-7.

A total of 33 different stamps was issued for each different resident and non-resident license privilege. The stamps measured 30 by  $23\frac{1}{2}$  mm, were rouletted and came in sheets of 5 (5 x 10) with a vertical gutter running the length of the sheet. Each stamp bore a different design.

The stamp program was not overly popular with sportsmen or the license agents in the first year. Some agents even elected to discontinue the sale of licenses. The 1984-85 license period thus brought several major changes. Both the sportsman and voluntary waterfowl stamps changed design. More importantly, the 32 individual privilege stamps were replaced with only 21 stamps, each showing only a different denomination. The law required that one stamp in the denomination of the proper license fee be attached to the passbook for each privilege. New bifold passbooks made from a softer and thinner paper were used. Figure 2 shows the annual passbook, which was on





a yellowish paper. At left is shown the use of a denominated stamp on the front of one license. At right is the back of another license, showing the use of the resident sportsman's license stamp, a copy with sheet and serial number. This license is missing the replacement stub, which is seen on the license on the left.

Following the end of each license season, the Commission has sold packets of unused stamps to collectors. They are sold until December 31 at which time all remainders are destroyed. Two hundred eighty six packets of the 1983-84 stamps were sold. The packets did not include the waterfowl stamp. For the 1984-85 license stamps, 84 packets, which did include the waterfowl stamp, were sold.

Having worked with a license agent for 20 years, an agent who sells over 5000 licenses a year, I can make some additional observations that will be of interest to collectors. The sale of the packets makes mint stamps not affixed to licenses fairly easy to obtain. Stamps on

licenses and in good condition are desirable and often very scarce. (Editor's comment: This is true for fish and game stamps of all states!). All nonresident and short term licenses are scarce. Most of these quickly make their way to the trash after use. Licenses for hunting privileges are generally discarded following the close of the season in February. The most common licenses are the resident state fishing and sportsman licenses. These account for nearly 90% of license sales. Trapping, special fishing devices, primitive weapons and county fishing licenses are seldom seen. Only a few hunting guide and shooting preserve licenses are issued.

Stamps are not used for licenses for nonpersonal special fishing devices, nonresident state trapping, falconry and guest fishing. These special licenses are issued by the Commission upon receipt of an application obtained from a license agent.

Most sportsman stamps on licenses are damaged. Due to the size of the stamp and its position on the license, almost all are creased or otherwise wounded. The other stamps fare better, but the vast majority are abused to some extent by the license agent or license holder, who view them as little more than pieces of paper.

The following listing is of all the license stamps issued by North Carolina for the 1983-84 and 1984-85 seasons. My thanks to the North Carolina Wildlife Commission for their assistance in the preparation of this article.



#### SPECIAL UTAH FISHING STAMPS

Located in the rugged Cedar Breaks National Forest in the southwestern corner of Utah is a small body of water called Panguitch Lake. Probably well known by the locals and those who frequent the nearby Cedar Canyon winter sports area, but not by many so-called "outsiders" is the fact that the fishing season for this lake is not in the spring, summer, or fall, but in the middle of winter!! The months being, specifically, January through mid March: Panguitch Lake is open to fishing through the ice from January 1 to March 15 of each year.

Starting in 1982 and lasting for a scant two years thereafter, the state Department of Wildlife Resources required each angler who fished the lake to purchase a special "Panguitch Lake Ice Fishing Stamp" which entitled him or her to catch and retain a limit of five trout from the lake.

The design for the three years these stamps were in use is identical, a minor exception being that the 1984 stamp shows Jan. 2 as the first date of the season, not Jan. 1. The stamps were issued in strips of unknown length. The angler received the stamp while the tab at left was retained by the seller.

Colors and methods of separation for each of the three annual stamps were as follows.

1982 Black lettering on white paper, perf. 12.

Black lettering on yellow paper, roul. 9½ horizontally and 6 3/4 vertically.

1984 Black lettering on blue paper, roul 6 3/4. The reasons for the discontinuation of the stamps after the 1984 season are unknown.

There were but a very small quantity of these printed each year and, to my knowledge, only one agent sold them. The state has advised that all remainders of these stamps have been disposed of.

OKLAHOMA MOTOR VEHICLE TAX STAMP.



These are affixed to manufacturers' certificates of origine before any motor vehicle can be sold at retail. The \$2 black on pink issue was shown in the Sept.-Oct., 1980 Newsletter. Some time after that the tax was increased to \$2.50 and was increased again to \$3.50 in 1985. The \$3.50 stamp, shown here, is black on blue paper, roul. about 4 3/4.
