## "BINGO" STAMP CHECKLIST

"Bingo card" stamps, also known as cab card stamps, are one of the most ignored areas of state revenue stamp collecting. These stamps are issued by state regulatory agencies to truck drivers who carry goods for hire. I have previously provided a description of the history of these stamps (Smiley, 1984a) and the federal regulations which resulted in their issuance as well as a preliminary checklist of the then known varieties (Smiley, 1984b). The present checklist is an update of that earlier listing. All years shown are the year of issue. Many of these stamps show an expiration date in January or February of the following year. All stamps are on white paper unless otherwise noted. Colors of serial numbers are given in (parentheses). The stamps are without stated monetary value unless one is noted. Where they are known, the tax or fee the stamps paid are shown. This checklist was compiled with the help of Doug Berryman and Ken Pruess. The list is current as of March 9, 1988. Collectors with stamps not listed, or with questions or comments, are asked to contact the author at Box 361, Portage, WI 53901. Ken Pruess did the bulk of the original work.

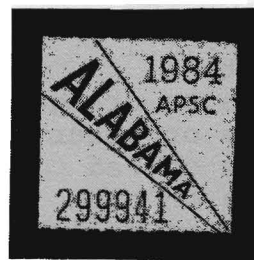

### DELAWARE 1976 TROUT STAMPS FOLLOW UP.

In the Jan.-Feb., 1988 issue (p. 5-6) Richard Bilek reported the existance of two distinct designs of the 1976 Delaware trout stamps. By far the more common design is a special 1776-1976 bicentennial type. Richard had found a \$2.10 1976 resident trout stamp printed in black on red in the "leaping trout" design used in previous years. Now new member David Curtis has reported a 1976 Delaware non-resident trout stamp in the "leaping trout" design. The stamp has a face value of \$5.25 and is printed in black on blue. As far as Curtis, a dealer in state fish and game stamps, knows, none of the 1976 "leaping trout" design stamps were actually used.
