Previous articles on the Brundage local southern tax decals have given no information on the format of the sheets in which these decals were printed. I have recently acquired four full sheets of these decals. A full uncut sheet measures 20 by 26 inches and contains 77 panes of 10 decals, arranged as shown above. On two of the four sheets, all the decals are the same. One sheet contains only 1¢ blue tobacco tax decals from the "Town of Hamilton" in Missouri. The other contains decals for the "Town of Altoona, ALA" tobacco tax. These are 2¢ and red. The other two sheets are composits in which two different decals appear in the same sheet. One sheet contains both 2¢ red "Town of Alabaster" (Alabama) 2¢ red cigarette tax decals and 2¢ red "Town of Hamilton" (Missouri) tobacco tax decals. In this sheet panes 1 through 21 and 26 through 35 are from Alabaster with the rest are from Hamilton. The second composit sheet contains 2¢ green cigarette tax decals from the "Town of Naturia" (state unknown) in panes 1 through 49 and 61 through 63. The remaining panes are of 1¢ green cigarette tax decals for the "Town of Thorsby" (Alabama). All the decals in all four sheets are of the standard tobacco

leaf design. Both the Alabaster and the Thorsby decals have not previously been recorded.

All the above are of the standard tobacco leaf design with the exception of the Phenix City 4¢ beer tax decal which is of the same design as the Tuskegee, AL beer tax decal illustrated on page 56 of the July-October, 1983 Newsletter (vol. 22, #s 4 & 5, whole # 162).

# NEW MEXICO FISH AND GAME STAMPS

As listed in the July-August, 1987 issue of the Newsletter (p. 47), New Mexico issues a number of different hunting and fishing stamps. Included are four different denominations of trout stamps, a \$3.25 turkey stamp, a \$10 "Valle Vidal" stamp and a \$5.25 "wildlife habitat and improvement stamp." Inquiry to the New Mexico Department of Fish and Game brought information on the uses of these various stamps. The four different trout stamps are used to pay different trout fees. The \$3.25 stamp is used on junior-senior fishing licenses which are sold to residents who are 12 or 13 years of age or over 64. It is also used on handicapped residents' licenses and on one day fishing licenses. The \$4.75 trout stamp is used on five day licenses. The \$5.75 trout stamp is used on resident fishing licenses and resident general hunting and fishing licenses. The \$7 trout stamp is used on non-resident fishing licenses.

The \$3.25 turkey stamp issued for the 1987-88 year was the last of a three year series. All turkey hunters were required to purchase the stamp. The Wild Turkey Federation contracted the artist for the stamp and had the stamps printed. The state sold the stamps and the money raised from the sale was designated for turkey research and restoration in the state.

The \$10 Valle Vidal stamp must be used by all hunters, trappers and fishermen in the Valle Vidal, a portion of the Carson National Forest in northeastern New Mexico. The \$5.25 habitat stamp is required on the licenses of all hunters, trappers and fishermen in the Jicarilla Division of the Carson National Forest and in all of the Lincoln National Forest and some adjacent lands.

The state sells only stamps from the current license year and these are sold at full face value. The address is New Mexico Department of Fish and Game, Villagra Building, Santa Fe, New Mexico 87503.

## MICHIGAN HUNTING AND FISHING BADGES

By Frank Sunday







During at least the seven year period from 1929 to 1935 Michigan issued hunting and fishing "badges" as well as regular paper licenses. These badges, very scarce, must be the most unusual type of hunting and fishing licenses ever issued. Seven different types have been seen so far and are listed below.

- 1929 Resident small game. Pictures rabbit.
- 1930 Resident small game. Illustrated.
  Resident trout fishing. Illustrated.
  Non-resident fishing. Illustrated.
- 1931 Resident trout fishing. Illustrated.
- 1932 Non-resident fishing. Illustrated.
- 1935. Resident's hunting. Non-pictorial.

From the high serial numbers on some of these, tens of thousands must have been issued. Where are they now? Have they almost all disappeared? STATE OF BLANK.

Shown at left, twice actual size, is either a sample or an essay for a 2¢ cigarette tax stamp. It is in blue on cream paper and is imperforate. The state seal bears some resemblance to the New York state seal.



WEST VIRGINIA.

Illustrated, twice actual size, is the current West Virginia heat transfer cigarette tax decal. This is red on white with pink safety design. There is a light grey "1770" over the base of the stamp which will not illustrate well. This is probably some identification number of the firm that affixed the stamp.



NEW YORK CITY.

The illustrated decal, shown twice actual size, is printed in black on orange. It appears to be a previously unreported type. It is on cream card with an inverted gret safety design. It has been cut close, so the type of rouletting can not be determined. This is a cigarette tax decal and probably dates from the 1940s.



ILLINOIS

Shown at left actual size is the decal version of the Illinois \$5 cannabis stamp. It is on cream card with no safety design, rouletted 5. Copies are available from Harold Effner, Jr. at face value. Whether decal versions of the other two Illinois controlled substances stamps were also issued is unknown at this time. These were shown in the July-August, 1988 issue on page 59.
