### MICHIGAN APPLE ADVERTISING TAX

Mr. Chas. H. Hermann has advised us that there was a 2¢ card in red which was in use for a short time before the 3¢ cards were put into use.

He also shows us several more of the 3¢ cards and we are going to endeavor to illustrate two of these, which differ in the type of serial numbers used. The one having the plain figures is the same design as that shown us by Mr. Markey for the January number.

Illustrations in this mimeograph reproduction. have given us trouble, particularly in certain shades of ink. They are taken directly from the stamps in most cases, and the violet color let us down in the illustration of Mr. Markey's card. To overcome this we tried a photographic process and find that of five cards used two came out very well, while the other three did not come out well at all.

An examination of the cards themselves show the printing to be in a little more reddish shade of violet, and that the card stock itself appeared to be a little darker shade of manilla. Whether a different ink was used, or the card absorbed the ink a little better, we don't know.



Cancellation dates on these cards run from February 16, 1959, to October 30, 1960.

The two with plain figures are cancelled October 4, 1959, and October 30, 1960, the latter one having the lower serial

LEE HEFNER COMES MEMORIAL LIBRARY DONATED TO THE UNIVERSITY OF SOUTHERN CALIFORNIA

The Lee Hefner Combs memorial collection of books, pamphlets, and periodicals on stamp collecting, given to the University of Southern California by attorney Lee Combs of Beverly Hills, is on display through February 28 in the treasure room of Doheny Library with postal and revenue stamps of selected countries of the world.

The exhibition is open from 8 a.m. to 10 p. m. Mondays through Fridays, 8 a.m. to 5 p.m. Saturdays, and 1 p.m. to 6 p.m. Sundays.

In the collection given the USC library are 300 bound volumes and many hundreds of pamphlets and periodicals that are out of print and collectors' items. They come from the United States, Canada, Great Britain, Japan, Hungary, France, and Finland.

The philatelic collection was presented by Combs in memory of his son who was killed in a traffic accident in the summer of 1959 while returning to California from his sophomore year at Yale University. Young Combs, named for his father and maternal grandfather, Oklahoma Supreme Court Judge Robert A. Hefner, former mayor of Okalhoma City, was valedictorian of the 1957 class at Harvard School in Los Angeles and light heavyweight boxing champion at Yale.

Combs said he will continue to build the collection, which includes such scarce items as a complete run, bound in half-calf, of the Belgian publication, "Le Timbre Poste," Volumes 1-38, from 1863 to 1900. There is also an almost complete run of "The Philatelic Journal of America," Volumes 1-19, from 1885 to 1905.

Also included are five volumes of Moen's "Catalogue Prixcourant de Timbre Post," 6th edition, 1886.

Among many scarce books devoted to the collection and study of revenue stamps is Toppan's "Historical Reference List of the Revenue Stamps of the United States," published in Boston in 1899.

Although the collection is primarily of reference works devoted to revenue stamps, there are also many volumes pertaining to stamp collecting in general. These include catalogues, books about philately, histories, and exhibitions of famous collections.

USC Librarian Lewis F. Stieg said the University library will have one of the outstanding philatelic collections in the nation when present library materials are added to the Combs gift.

Attorney Combs, a 1929 graduate of the USC School of Law, is a member of the USC Associates; Legion Lex, support group for the law school, and Skull and Dagger, all-University men's honor society. He was a three-year pole vault letterman at Harvard University, and continued his athletic interest as regional chairman of the U. S. Olympic Games Committee. Currently, Combs is co-chairman of the U. S. Equestrian Team Committee. He is trustee of Harvard School in Los Angeles.

The Smithsonian Institution, Washington, D. C., also is a recipient of a Lee Hefner Combs memorial collection of state

revenue stamps, to which additions will be made.

Both the USC and Smithsonian collections were appraised as irreplaceable collectors' items by a leading philatelist, Elbert S. A. Hubbard, of Northridge, California.




