## Hines To Depart For Poland

### *New Secretary Sought*

State Revenue Society President and Secretary Terence Hines will transfer to Warsaw, Poland in May, a move he describes as a too exciting an opportunity to pass up.

Hines confirmed the move as the *State Revenue Newsletter* was going to press. In a letter to the SRS Board of Governors Hines noted that the tour will last from two to three years.

"This move has obvious implications for the various positions I hold with the SRS," Hines noted in his letter. "I will obviously not be able to be the SRS librarian or secretary in Warsaw! I must thus resign from these positions as soon as replacements can be found.

"As to the presidency, I will leave that up to the Board. If the Board thinks it best that I resign, I will do so. If not, I will continue as president until the next election."

Hines has appointed Peter Martin, the *State Revenue Newsletter* editor, to succeed him as librarian, a transfer that will be made early in 1992. Martin will also become the Society's American Philatelic Society representative.

The secretary's position has not been filled and anyone interested in serving the society in this capacity is urged to contact Hines as soon as possible. Access to a computer to print mailing labels is desirable.

Hines will provide additional details of his move in the January-February President's column.

## Superior To Auction Hubbard California Revenue Collection

The California State Revenue collection of pioneer revenue dealer Elbert Hubbard, will be included in the November 19-22 "Beverly Hills" sale conducted by Superior Auction Galleries, Beverly Hills, Calif.

According to Superior's Michael Orenstein, the collection of 1857-1869 California revenues, the nucleus of which was owned by Lord, Ward and Combs before being acquired by Hubbard several decades ago, contains virtually all known stamps as well as numerous unrecorded items.

Areas included in the collection include bill of lading, exchange, insurance, marine insurance, attorney at law and passenger issues in both circular documentary (including round and square as well as hexagonal and star cut varieties) and rectangular revenue (including round and square varieties) formats. In addition, there are proofs and essay issues.

Orenstein reported that the lots, many of which have never been offered to collectors, represent one of the largest, most complete offerings of these issues ever made.

Part I of Hubbard's collection contains more than 375 lots and will be included in the "Beverly Hills" sale. This section will be presented as "Mail Bid only," so as to offset any disadvantage to collectors and dealers unable to attend the sale in person.

The auction catalogs for this sale were distributed to customers on Superior's mailing list in mid-October. According to Orenstein, several additional sales are planned, but details have not been finalized.

The four collection are: 1. Cigarette and tobacco-paper stamps (no decals); 2. Inspection tax and fee stamps-mostly agricultural inspection material, but also items such as the Connecticut elevator inspection stamps; 3. State decals for any type of tax including liquor, tobacco and cigarettes; and 4. State liquor, wine and soft drink paper stamps.

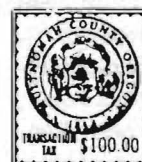

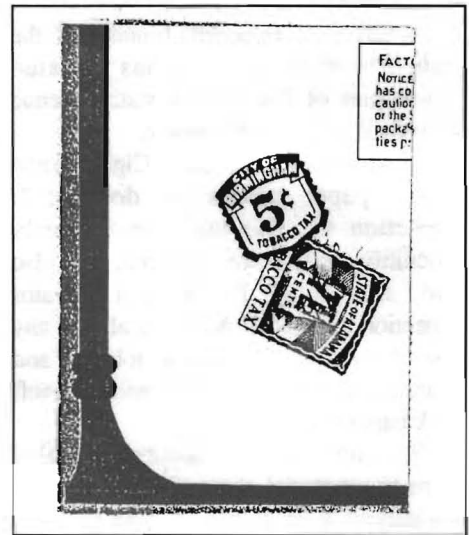

## Unusual Utah Stamps In Hubbard Collection



Illustrated enlarged above is an unusual item from the Hubbard tobacco tax stamp collection. This tiny (12mm x 15mm, perf. to perf.) stamp resembles the basic Utah cigarette stamp (also shown for comparison) but differs in several major respects: it carries no state name, the printing is cruder and the Indian is facing to the left, not to the right. Three different varieties of these stamps are known: a 2-cent red, a 5-cent blue and a 5-cent ultramarine. Whether they were produced by the state or, as is more likely, produced privately for some special purpose, is unknown. (By Terence Hines)

## Illinois Report Lists Cannabis Sales

The 1990 Illinois Annual Report reflects that during fiscal year 1990, 20 cannabis stamps (\$5 denomination) were sold and no controlled substance stamps (in either the \$250 or \$2,000 denominations) were sold, for a total collection of \$100.

In addition, the department collected

\$215,216 from assessments from this tax.

In 1989, 116 cannabis stamps and three substance stamps were sold and \$1,395 in cannabis/substance taxes were collected. In 1988, 790 cannabis and one substance stamps were sold and \$4,206 in cannabis/substance taxes collected. (By Harold Effner Jr.)

## Most State Liquor And Beer Stamps Discontinued

### Feed, Fertilizer Inspection Stamps Also Stopped

Most state-issued liquor and beer stamps have been discontinued in favor of a report system. Feed and fertilizer inspection stamps have also been discontinued.

State stamps discontinued since 1940 include: Alabama oleo; Alaska liquor, beer, and wine; Arizona liquor and wine; Arkansas feed, beer, and malt; California liquor; Colorado liquor, fertilizer, and beer; Connecticut elevator; Delaware cigar; D.C. liquors; Florida feed and fertilizer; and Georgia feed, oleo, cottonseed and seafood.

Also, Idaho beer, malt, and oleo; Illinois liquor and beer; Indiana beer and malt; Iowa feed and oleo; Kansas liquor, beer, feed, livestock remedy; Kentucky liquor, feed, and fertilizer; Louisiana liquor, feed, paris green, and insecticide; Maine beer; Maryland liquor Michigan beer, feed and

malt; Mississippi beer, wine, malt, feed, fertilizer, seed, and cotton seed meal; and Missouri liquor, beer, wine, and gasoline, export beer and apples.

Also, Nebraska liquor, beer, wine, export beer and feed; Nevada beer, wine, and liquor; New Mexico liquor, beer, wine, feed, hone fertilizer and cigars; North Carolina liquor, beer, wine, seed, insecticide, feed, fertilizer, linseed oil, import beer, and land plaster; North Dakota cigarette papers, beer, and feed; and Ohio liquor, beer, and wine.

Also, Pennsylvania, soft drinks; South Carolina fertilizer and oil; South Dakota beer; Tennessee liquor, wine, malt, oleo, seed, feed, fertilizer, and cigar; Texas liquor, and beer; Utah hunting, oleo, beer, and feed; Virginia seafood and feed; Washington beer, wine, and fruit; Wisconsin beer; Wyoming liquor.

# Minnesota Announces Sale Of Duck Stocks

Beginning this past October 15, the Minnesota Department of Natural Resources (DNR) mounted its first and final nationally advertised sale of noncurrent Minnesota waterfowl stamps. The sale will run for six months, through April 15, 1992. The noncurrent stock held by the DNR has been reduced to 3,000 sets of stamps, beginning with the first year of issue, 1977, and continuing through 1990. The sale is for complete sets only. Singles are \$60 per set, sheets of ten are \$600 per set. All sets unsold after April 15 will be destroyed.

Until 1984, the Minnesota DNR held all of its unsold noncurrent waterfowl stamps, and made them available to collectors at face value on a per-request basis. In 1984, what was an enormous inventory of noncurrent stock was reduced to 25,000 examples of each year's issue, and has been annually reduced since that time to the current remaining stock of 3,000 examples from each of the years 1977 through 1990.

The many concerns surrounding collectible stamps and their fair market value were thoroughly studied by the Minnesota DNR before setting the terms and conditions of this sale. Investigation was made into the retail market, and officers of nationally recognized non-profit philatelic organizations were consulted in order to determine the best methods for generating revenue for wetland development without undermining the current market for these collectible issues.

"We're confident that the manner in which we are conducting this sale respects the concerns of these very different interests," said Stephen Seefeldt, marketing specialist for the Minnesota DNR License Bureau.

"Naturally, our first concern must lie with the condition of wildlife and wildlife habitat," Seefeldt added. "But at the same time, we feel a responsibility to the group of people who are, relatively speaking, a new constituency in the field of wildlife management: stamp collectors. We were fortunate in this instance to have a win-win

situation on our hands."

Minnesota's policy concerning future issues will leave the business of collectible stamps to the stamp collectors. The DNR will make each year's issue available to collectors at face value for a period of one calendar year beyond its expiration date,

These sets are in new, unused condition and will be available for purchase for a period of six months only, from October 15, 1991, through April 15, 1992, after which all unsold stock still held by the Minnesota Department of Natural Resources will be **destroyed**. This final offer is for complete sets of single issues at \$60 per set, or complete sets of sheets of 10 at \$600 per set. **No individual stamps or partial sets will be sold.**

***Proceeds from this sale will be contributed to the North American Waterfowl Management Plan for waterfowl habitat development.***

In order to accommodate individual collectors, orders for 1 set of singles or sheets will be filled immediately upon receipt. Orders for more than 1 set of singles or sheets will be processed as follows: Upon receipt, 1 set will be sent immediately. Beginning on March 15, 1992, the balance of all multiple orders will be sent in the order that they were received, until all 3,000 sets are sold. Orders postmarked later than April 15, 1992 will not be honored. Where demand exceeds supply, refunds will be made by the Minnesota Department of Natural Resources.
