Martin Assumes SRS Presidency

Peter Martin, Springfield, Va., became the State Revenue Society's fifth president in elections concluded in January. A total of 52 validated ballots, 25 percent of the membership, were received by the January 15 deadline.


Martin, who received 50 out of 51 votes, succeeds Terence Hines, who had served as president since 1975, the longest term of any SRS president.

Martin will continue to edit*The State RevenueNewsletter* and to serve as librarian. As immediaite past president, Hines will continue to serve the society on the Board of Governors.

In other election results, Harold Effner Ir., Lincroft, N.J., was re-elected vice president and treasurer and Scott Henault, Dedham, Mass., was elected to a full term as SRS secretary.

In a close vote, Ronald Lesher Sr., Dr. Edward Miles and Tim McRee were selected for the three Board of Governor seats. Lesher, who was recently elected as the American Revenue Association president, led the way with 45 votes. Just five votes separated second through fourth place in the balloting.

All terms are for two years. Complete voting results are listed on page 3. Previous SRS presidents were SRS founder E.S.A. Hubbard, Santa Clara, Calif. (1955-1969); O.R. Bloom, Barberton, Ohio (1969-1972); Mack Mateson, Lynwood, Wash. (1973-74; and Hines, Chappaqua, N.Y. (1975-1992).



SRS Auction A Big Success

The first SRS action that closed November 15 was an overwhelming success with all but three of the 80 lots being sold. Bidding was competitive as 56 lots (70 xercent) sold at or above the estimate

Of the 23 bidders, 16 were successful 70 percent). The lots submitted by the five consignors realized 405.50.

Lot 55, a group of eight older Texas iquor tax paids, received the most bids, tine. Listed at the \$1 minimum bid, it sold or \$3.50

Lot 7, a set of seven Alabama feed stuff tamps on feed tags received eight bids and vas hammered down for \$8 against a \$2 stimate. Lot 54, a South Carolina promissory otc and will with documentary stamps ttached received six bids and sold for \$5.50 gainst a \$2 estimate.

Other lots receiving at least five bids ere lots 13, 27, 53 and 60. The highest price

realized went to lot 3, an Alaska MNH liquor block of four Hubbard L14 stamps, that fetched \$25.The next highest price realized went to lots 35 and 34. The Kansas beer stamps sold for \$22 and \$21.

The highest bid received was \$80 for lot 35. It sold for \$22. All lots were sold at one increment above the second highest bid. There were also five tie bids with the winner being the bid with the earliest postmark.

The biggest bargain was lot 30, a block of four of the first issue Kansas 1937-38 quail stamp. It catalogued for \$50 and sold for \$12.50.

A complete list of prices realized from Auction #1 is on page 11.

Because of the success of the auction, the Society will sponsor two auctions in 1993. Consignments for Auction #2 are due by March 26; for Auction #3, by August 31. Auction details are included on page 10.

President's Notebook By Peter Martin

The 1992 SRS elections are now complete and for the first time in nearly 20 years the SRS has a new president. The elections bring two things into focus. First, the fact that the society has been fortunate to have had the dedicated service of Terence Hines for such an extraordinary period of time. We all owe Terry a debt of gratitude for his long-term service and on behalf of all SRS members I say, "Thank You!"

Second is the member response to our elections. SRS treasurer Harold Effner Jr. validated 52 ballots, meaning that we had a response rate of approximately 25 percent of our membership. While national and elections normally receive participation from about 50 percent of registered voters, our election participation is quite high for a philatelic organization. In fact, in the recently completed American Revenue Association elections, out of a membership of more than 1350, only 31 members chose to vote.

The fact that every vote counts is once again dramatized by the close vote for our Board of Governors. The difference between second and fourth was only 5 votes.

Thanks for making your voice known. As we move toward the 21st century I want each of our members to continue to make their voices known. This organization can only continue to grow with the participation of all.

I plan to use this column to keep you apprised of the directions that your elected board plans to move the society. We plan to build on the foundation that Terry and previous officers have established.

This month I want to highlight the overall objectives that I hope we can achieve during my term. I will describe them here briefly. In coming columns I will provide you with details about how we plan to implement them.

My broad objectives are to: increase SRS membership; ensure the long-term financial stability of the SRS; continue to improve/expand SRS services; establish a publications program; review/upgrade administrative procedures; promote the SRS nationwide; establish an awards program; and improve communications/contact with the membership.

To improve communications and contact with the SRS membership, I will be plan to increase participation within the SRS. In short, I want more people involved in promoting the society and its agenda.

To this end I will be appointing regional SRS coordinators who will be charged with promoting the SRS at stamp shows within their region, appointing state coordinators within their region and encouraging SRS membership within their region.

I foresee five to 10 regions. Anyone interested in serving as this voluntary position should contact me immediately. Include a shortbiography, what states you are interested in supporting and your address and phone number.

Regional coordinators will receive the same mailings that go to the Board of Governors and will therefore be able to represent their region and comment on proposals before they are voted on by the Board.

I will also be appointing a special staff to help with various SRS functions. Currently I am seeking a society attorney, an auctioneer, a photographer, a historian, an awards coordinator and a convention coordinator. If you are interested in supporting your society in these, or any other area, contact me today.

A third goal to improve contact with members will be to establish an annual meeting/convention. More than likely, we would participate with an existing show. Since many SRS members are also ARA members, we could consider holding our convention at the same location as the ARA. In 1993 the ARA is meeting at CHICAGOPEX in the fall. What do you think?

Your comments are always welcome. Write meat POB 505, Springfield, Va. 22150. If you would like an individual response, please include a SASE.

I look forward to working with each of you for the betterment of our hobby.



Oregon Duck Fee Update

Bob Dumaine's November-December State Revenue Newsletter column brought a note from Mack Mateson, Edmonds, Wash.

Regarding the table of fees imposed in addition to the stamp's face value, Mateson reports some additional information for Oregon.

When a collector places an order in Oregon, the order form states that the \$2.50 postage and handling charge can be waived IF the collector includes with their order, the necessary SASE along with protective forms. Therefore, imposition of the fee rest with the collector, not the state.


Newsletter Indexer Needed

Shown above are two Arizona Big Game permits. The top illustration is a pressure-sensitive stamp that was affixed to a ram shot in 1988. The stamp was wrapped around a leg so that the excess ends of the sticky back extended beyond the leg and were then pressed together. The circular marks shown on the stamp are perforated slits that may have been intended to be torn apart when the stamp was removed from the leg. The hunter was very careful and the stamp was saved along with a layer of hair from the ram sticking to the glue and a little blood as the only defect. The bottom illustration is also a pressure-sensitive stamp for use when a non-resident hunter ships a trophy , instead of transporting it home. Some collectors consider the "Big Game Hunt Permit-Tag" a stamp, regardless of what it is labeled. It is required to hunt "any ram." (By John Stewart)

"Featured Usage" is a new column that will appear regularly in the SRN. This month's usage is a Connecticut elevator license used by the Reed-Holroyd Company in Meriden for a freight elevator. The license is on a light green paper with \$1 inspection stamps for 1950 through 1953 attached. The 1950 stamp is blue;1951 green; 1952 rose and 1953 brown. All are perforated 12. The stamps were issued by the Connecticut Department of Labor and Factory Inspection beginning in 1946. The back of the license is blank. The January-February usage was submitted by Byron Sandfield, Dallas, Texas. 
Alaska Requires New King ^I Salmon Fishing Stamp

An article in the February 1993 Alaska magazine reports that Alaskan king salmon fishermen are now required to buy a special fishing stamp.

The stamp, \$10 for residents, \$20 for non-residents, is required for both freshwater and saltwater angling.

Proceeds from the sale of stamps will go toward enhancement, research and all aspects of king salmon management, according to Rocky Holmes, deputy director of the Alaska Fish and Game's sportfish division.

In addition to this stamp, the legislature raised the cost of resident sport fishing

licenses in 1993 from \$10 to \$15 and resident hunting licenses from \$12 to \$25. Enforcement of the new law rests with the Fish and Wildlife Protection agency. (By Dick Bilek)

New Duck Album Released


The Sam Houston Duck Co. recently announced the release of their International Conservation and Duck Stamp Album.

Bisbee, Arizona Occupational Licence Stamps Have Two Unusual Designs

Recently I had the opportunity to visit Bisbee, Ariz., a city on the National Register of Historic Places historically known for the Queen Mine.

The mine was operated by the Copper Queen Consolidated Mining Company from the late 1800s to the mid-1970s.

Besides its history, Bisbee is becoming well known for the artist colony that has evolved there during the last decade. Touring the turn of the century Victorian structures and enjoying the old west and copper mining lore can be a real pleasure.

A more recent event of some philatelic importance is when Bisbee began validating the "City of Bisbee Occupational Licenses" with stamps. Based on local corporate

knowledge, the stamps were used at least as early as 1980.

The stamps used through 1991 depict a mule toting a minor's pack (figure 1). There were four different stamps used. The stamp design is in black and is the same for all four stamps, but each have a different background color; orange, yellow, red, and green. A different color stamp was used each quarter to denote payment of Bisbee's business license tax (figure 2). The fee paid is not printed on the stamps, the required taxes for each different type of business are listed on the license's reverse (figure 3). The color of stamps used for each quarter from 1989 through 1991 are shown in the accompanying chart.

In 1992 the stamp's design was supposed to be changed to a mining car (figure 4) and background colors were to change to orange, yellow, red, and blue.



Unfortunately, the

stamps were not available in time to issue to businesses who paid their first quarter 1992 taxes prior to mid-March 1992. Instead of waiting for stamps with the new design and backlog payment receipts, the old orange mule stamp was used. For businesses who paid their first quarter taxes after mid-March 1992, they received the new mining car stamp for validation.

All stamps used so far have been printed by the Bisbee Gazette, have a pressuresensitive adhesive (with wax-paper backing), and are imperforate. On a personal note, besides the enjoyment of finding stamps that were new to me, the people I talked with at Bisbee's City Hall and in local businesses on my hunt for licenses and information were some of the nicest people I have had the pleasure of meeting. I very much look forward to visiting Bisbee again.


The receipts are organized by province. Both government and vendor issues are listed. The author has coded each provincial item and provides whatever information is known about these issues.

Historical References Shed New Light On Nevada Documentary Stamps

"...The Act was apparently modified at least once, the modification changing some of the tax rates. Unfortunately, I have not be able to obtain copies of the modifications..."

This excerpt is from a 1990 State Revenue Newsletter article by Terence Hines. After reviewing this work I embarked on an attempt to locate the modifications eluded to in this introduction. With the help of Earl Stritzinger I was able to fulfill this goal.

First, the matter of the tax as it applied to checks. From the Hines article comes an illustration of a check dated Nov. 4, 1869. (Please take note of the year). Hines indicated that the check "...bore a two-cent federal revenue stamp, paying the federal check tax, and a two-cent orange Nevada revenue..."

Since Hines only had the First Act as his point of reference he challenged the need for the existence of a tax on checks since the actions of the First Legislature simply indicated that checks "made and made payable in the State of Nevada were exempt from tax." Others checks were taxed twocents each if they were over \$100... (the check illustrated by Hines was for a mere \$6.30). What was unavailable to Hines was the fact that the tax on checks, and more specifically Bank Checks (i.e. as it applied to the illustration in question), rested not with the actions of the First Legislature, but with the Second, approved Mar. 1, 1866. The following excerpt refers to it.

"Bank Check. Bank checks, drafts, or orders at sight, or on demand made and payable in the State, two cents."

Hines went on to note that "...Parts of the Act are poorly written and unclear..." which can be reinforced by these excerpts which, for whatever reason, differentiate between a Bank Check and a Check.

"Check, draft, or order. Check, draft, or order for the payment of any sum of money exceeding ten dollars, upon any person, at sight or on demand, two cents."

The imposition of the tax c. *i checks* was not in force for a particularly long period of time. By the close of the Fifth Legislative Session, approved Mar. 4, 1871, all mention of *checks* was to have been stripped from the tax schedule. Therefore, the imposition of this tax regardless of form, lasted a mere five years (1866-1871).

Initially, I felt that the removal of *checks* as an item subject to the Nevada state tax, in itself, was of no particular importance, yet in developing this article I was to find that the 1871 date was to have a very special unforeseen significance.

While preparing this article I felt that an additional illustration of a check might be appropriate. As Hines had a fine example of an *adhesive* issue I chose Revenue Stamped

Paper (RN) integrating a two-cent Nevada revenue into the design. Figure 1, Scott RN-C21b was my choice.

At first glance, the year date literally jumped off of the check "1872!!!." Could there have been others or was Figure 1 a mere aberration? In an attempt to show usage after that critical March 1871 date I leafed through Castenholz, pages 46-47, where I found juxtaposed illustrations of an RN-C21 dated Jan. 2, 1872.

The illustrated check had a space allocated as part of the design for affixing an *adhesive revenue*, which in their illustration was conspicuously missing. The fact that the stamp was missing was historically correct, yet on the adjacent page was an illustration of an RN-C21b with the crucial date of Aug. 6, 1872.

Heretofore I must have examined Figure 1 numerous times, but it was not until I looked at it in reference to the removal of the tax on checks that the date struck home. Why was this RN-C21b being used after the repeal of the tax on checks? That's a subject I'd like to leave open for discussion in a future article.

The Hines article also challenged the need for a tax on assay reports, providing select explanations for the existence of this category by again using the actions of the First Legislature as his guiding reference.

In retrospect I may have sided with Hines if I didn't have access to the provisions of the Second Legislature enacted Mar. 1, 1866. From that enactment the following passage appears:

Certificates, Certificates of assay, five cents

This particular passage remained in force until Mar. 4, 1871. Although the action of the Fifth Session resulted in removal of the specific tax as it applied to Certificates of Assay, this was replaced by a catch-all provision that stated "...Certificates of any other description than those specified, 5 cents..." One could infer from this that Certificates of Assay remained subject to this tax based on this passage.

Can anyone provide us with a certificate dated on or after this critical date? I solicit others to take an active interest in examining their own collections in the hope that they can add to this new information.




