## SRS Auction #3 Another Huge Success

When the dust from State Revenue Society Auction #3 had settled, the results again showed that members find this service a real benefit. The third auction continued the trend of the first two SRS offerings with more lots, more bidders and a new record for sales.

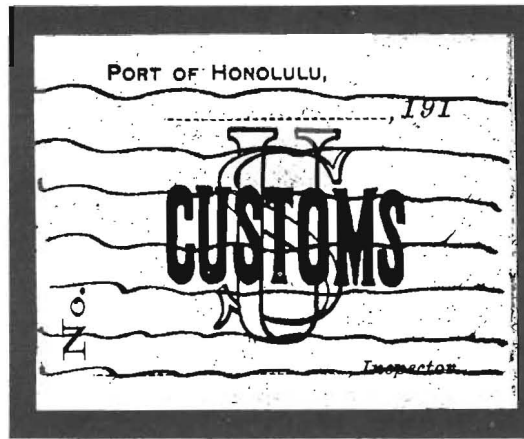
The March 28 auction offered a record 335 lots and all but 41 of the lots were sold. Auction #2 had 127 lots.

SRS members who placed bids went away happy as 28 of the 31 bidders won at least one lot and two of the non winners lost on ties.

The new twenty-five cent bidding increments made a difference as members who took advantage of the change were able to acquire more lots than those who didn't. Even so, there were still 14 ties, including three triple ties, that had to be broken by the earliest bid postmark.

The most interest appeared to be in the hunting and fishing stamps, especially Virginia, West Virginia and Guam, taxpays and cinderellas.

Areas that received the least attention and offered some real bargains included New York stock transfer stamps, Pennsylvania beverage and real estate

transfer tax stamps (seven of 13 lots received no bids), cigarette stamps and North Carolina hunting licenses.

U.S. first issue revenue stamps were totally ignored. Not one of the eleven offered lots received a bid. The stamps catalogued between \$6 and \$45 and, with the auction's \$1 minimum bid and no reserve, offered a real bargain opportunity.

The stamp that drew the most interest was lot 299, an early twentieth century used Port of Honolulu customs label with a \$1 estimate. The lot received eight bids and

realized an auction-high \$27. According to several sources, it is an unlisted label.

Four other lots received seven bids. Lot 62, an unused Indiana 10-cent pheasant legal food sales stamp sold for \$4.25; lot 118, a Michigan label that provided the health warning that fish from some Michigan waters contain mercury, sold for \$4; lot 302, a group of four different green bottle stamps with mixed company cancels sold for \$6.25; and lot 304, a group of five series 1931 oleo stamps went for \$2.25.

The top five prices realized were lot 299, \$27; lot 43, three Florida documentaries (D58, D61, D63) with a Dickenson signature, \$12.25; lot 46, a used \$10 Florida documentary stamp (D63) with a Dickenson signature, \$10; lot 228, a set of three different used Pennsylvania real estate transfer tax stamps with unlisted black control numbers, \$10; and lot 266, four different 1952 Utah trout stamps, \$10.

The next SRS Auction will appear in the November-December *SRN*. The consignment deadline for SRS Auction #4 has passed, but the Auction #5 deadline will be announced once a new auctioneer has been named.

## Troutman Named SRS Secretary

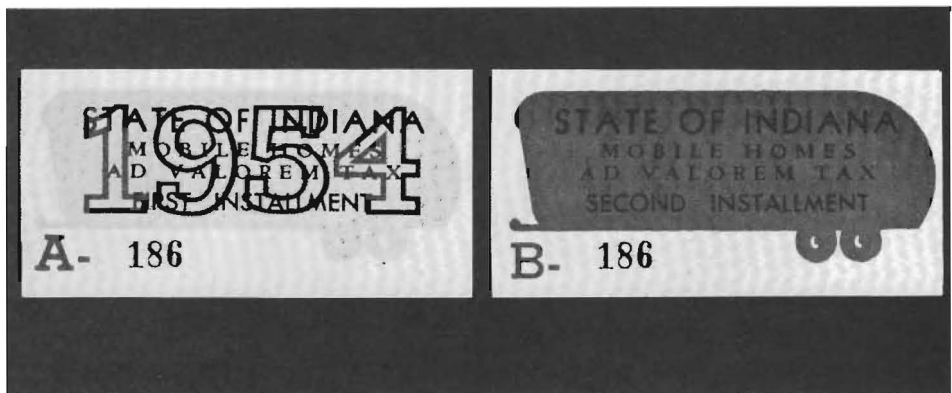

## Information About Indiana Mobile Home Tax Stamps Sought

Shown above are two decal-type Indiana mobile home ad valorem tax stamps. Both stamps measure 3 1/16 by 2 1/8 inches.

The items illustrate a mobile home trailer with the year 1954 superimposed on the trailer. The wording "State of Indiana, Mobile Homes Ad Valorem Tax, First Installment" is superimposed on top of the date on the "A" stamp and the same wording, except "First Installment" is replaced by "Second

Installment," is superimposed on the "B" stamp.

Both stamps are on a yellow background and have orange serial letters and black serial numbers.

The "A" stamp has the trailer in light blue with an orange date and black lettering, while the "B" stamp has an orange trailer, a light blue date and black lettering.

## Arkansas Discontinues Trout Stamps

The Arkansas Game and Fish Commission reports that the 1993-94 trout stamp was the last in the series. The trout stamp was discontinued effective Dec. 31, 1993.

The trout stamps were issued each January 1 beginning in 1991. The stamps are scheduled for destruction three years from their date of issue.

The 1991 stamp is no longer available, but the 1992-93 and 1993-94 stamps can still be purchased.

Single stamps are \$5, plate blocks \$20, sheets of 10 are \$50 and bound booklets are \$100.

Collector's series stamps are available in the 1-5,000 sequence. No specifically numbered stamps, plate blocks or full sheets can be guaranteed.

Fisherman's series stamps in booklet form are in the 5,001 to 150,000 series. The booklets are only sold in full booklets.

Non residents are required to send cashier's checks or money orders, payable to the Arkansas Game and Fish Commission, for orders of more than \$20. VISA and Mastercard are also accepted.

## But Illinois Offers New Trout Stamp

Illinois has taken a different tact and, effective in 1994, will offer a Lake Michigan salmon stamp and a newly introduced inland trout stamp.

The fee for each of these stamps will be \$6.50, instead of the current \$2.50.

## 1969 New Hampshire Mint Cigarette Overprint Unknown

One of the rarest New Hampshire state revenue stamps (not counting the contrived duck stamp governor's editions) is the 1969 7 1/2-cent on 5-cent yellow orange tobacco tax decal (T210 in *The Revenue Stamps of the New England States*).

This stamp was issued to pay the tax on packs of extra-long cigarettes when the price was increased in 1969. The New Hampshire tobacco tax was a function of the retail price of tobacco products and so when the price of these cigarettes was increased, the tax increased as well. At the time of issuance of these stamps the tax rate was 30 percent of the retail price.

I was a high school senior in May 1969, working in Putnam's Drug Store in Hanover, N.H., when the overprinted stamp appeared. By the time I saw copies on the cigarette packs we sold and contacted the state to try to buy mint examples, all had been used. To this date, no examples of this stamp in mint condition are known in collectors' hands.

Now, 25 years after the stamps were issued, it turns out that at least one full sheet, consisting of 10 panes of 10 decals, existed with an inverted overprint.

A New Hampshire resident who collects state revenues wrote to me and reported that "Once I had in my hand a partial sheet of the 7 1/2-cent on 5-cent (T210) with inverted overprint. The girl (in the tax office) said the boss had ordered them withdrawn due to the error. I always regret not having begged her to sell me just one."

Needless to say, no examples of the inverted overprint variety are known in collectors' hand. This article simply documents the existence of such a variety.

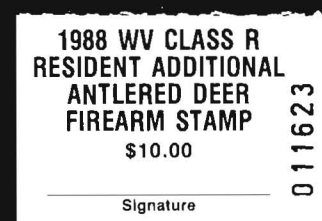

### SRS Sales Philosophy

Why does the SRS purchase these stamps?

The following “rules of thumb” apply:

- there is a discount for a large order (a discount that can be passed on to SRS members).
- the sale of the stamps will expire before SRS members can be notified in the newsletter.
- the stamps are non-fish and game (e.g. wine, liquor, cigarette).
- the stamps are fish and game stamps that are not readily available.
- there is a minimum purchase requirement.

**Note:** Certain stamps may have a purchase limit to give all members an opportunity to obtain these stamps.

The Washington Department of Wildlife's 1994 migratory waterfowl stamp is now available for purchase. Single stamps

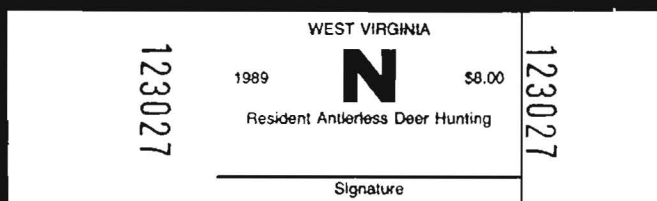
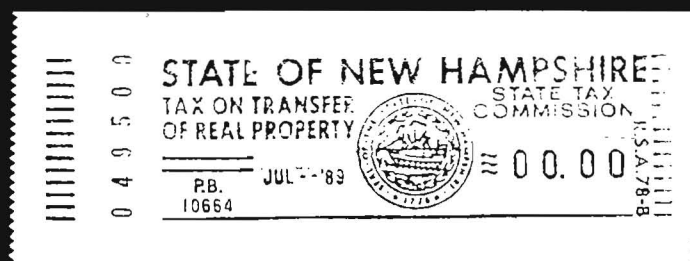
