Second Hubbard Sale

I heard Nutmeg's sale of the documentaries went well, or as Peter would say it was a rousing success. Some of the North Carolina documentaries were the stars of the show coming in at \$330.

Revenue Show at New York

I did not make it to the Revenue Show in New York. Between my neighbor backing out on the trip, my sister who I planned to meet getting sent to Scotland, and three days for me in the hospital with a salivary stone, I never made it.

"New Hubbard" Catalog

I continue to plug along on the new catalog. All the SRS auctions results have been used to adjust prices and I have begun the endless task of scanning new images of the stamps. I thought I would use this opportunity to discuss more plans as it evolves.

Specimens and Proofs. My plan at this point is to include all the specimens I can identify and use an S suffix. Most of the specimens are either Columbian Bank Note overprints or perfins, American Bank Note specimens, with a few others scattered about.

Proofs will probably be dropped. Many of these are progressive, or large and small format. A more detailed state catalog is needed to cover these properly.

<u>Airport Stamps</u>. These are a peculiarity. They were authorized by the federal government, but issued by specific airports or airport authorities. They probably should be in a municipal catalog. My plan is to include them as there is no other real source for pricing information.

<u>Scale and Gas Pump Seals</u>. I do not plan to include these in the big catalog. Much as I personally enjoy them, they have just not been studied enough to number.

"Bingo" stamps. These are another peculiarity. These were used on Interstate Commerce Commission forms (ICC) but were issued by the states. Issuing agencies vary from state to states: Departments of Transportation, Public Utilities Commissions, etc. I plan to include them, but have changed the prefix to ICC. They will be under the heading of the issuing agency (example Public Utilities Commission stamps) but will have a unified prefix. In the North Carolina catalog I didn't number these - in the big catalog I plan to number them.

Eggs. These are in the new catalog and should have been in the old catalogs.

Motor Vehicle. Here is a real gray area. New York has some windshield stickers that were apparently remaindered and are seen with some frequency on the market. These I plan to include. A few states had paper or windshield license plates during WWII. These I plan to list where known. Some like California's 1944's are common, other like Oregon and Oklahoma are very rare.

<u>Can lids and crowns.</u> Beer and soft drink taxes were sometimes put directly on the lids, bottoms or crowns (inside of bottle caps). I plan to note where this was done, but not detail them out. This is better done is a state catalog.

State Revenue News Alabama Egg Inspection

There seem to be many types of egg inspection stamps used in Alabama, and this is the first comprehensive attempt to describe them, incorporating articles by Hubbard, Hines, Hermann and Smiley. ^{1,2,3,4} It is likely that there are additional items not reported here, but the author wishes to offer particular thanks to Bill Smiley for his assistance in preparing this.

Used examples may show rubber stamped date of inspection, date or control numbers.

Using the large (8-1/2 x 5 -1/2 inches) label as a starting point. the author has made some inference about the order of usage which may not be correct. This label is known with and without the last line reading "A.W. Todd, Commissioner." Todd was commissioner from 1955-59 and again from 1963-67. A used copy of this label with the Todd line is dated October 30, 1957. This label is listed first, which the same label without the Todd line is ascribed to the next commissioner, "Red" Bamberg, Jr., who held the office in 1959-63, between Todd's two terms.

It is more difficult to ascertain the dates of use of the remaining labels. Hubbard's 1963 article helps to date some (Hubbard noted four types), while Hines' 1969 article adds others (Hines noted six items in current use). Hermann offered his listing of six types in 1970. Finally, Smiley illustrated eleven types in 1996.

Hubbard noted in his 1963 article that the inspection fee on eggs sold in Alabama was based on the rate of four cents per thirty dozen as of May, 1952.


The large format labels have an inscription referring to the Alabama Egg Law, Act No. 46, Legislature of 1955, Second Special Session. Hines noted the same rate was still in effect as of 1969.

Most labels were prepared for use in egg carton handling machines and were sold in rolls. There were three types of machines in use, each requiring a different size label. The largest label, 2-7/16 inches in width was required for Diamond National equipment. The label used for Continental Can Company was 1-1/2 inches wide. The smallest label was 1-1/4 inches wide for use with Page Automatic Heat Sealing equipment. Perforated stamps were prepared for use on single cartons of eggs.²

Hines stated that all six types in current use in 1969 were available in quantity from the Poultry Division, State Department of Agriculture and Industries.



North Carolina Gas Pump Seals

In an earlier article on the short lived term of Britt Cobb as North Carolina Department of Agriculture Commissioner (SRN 2nd Qtr. 2005), I had thought there was only one gas seal issued with his name on it. I was wrong. I have now found a second one in a horizontal format. It is also black on orange. We have never ascertained whether these are scale seals or just another format for different kinds of gasoline pumps. Many of the recent gasoline pump seals have both formats, as can be seen in Scott Troutman's new North Carolina Revenue Stamp catalog.

In 2005, the state redesigned the vertical format gas pump seal and I have now seen two different versions of the new design - one with the commissioner's name on it and one without it. What the reason was for the one without the name, I do not know. The new designs for 2005 are black and white on green.

A Pennsylvania Egg Stamp?

One day I happened to notice that the eggs I bought at the store had a keystone on the box with the indicia

"PA-149 PENNSYLVANIA CERTIFIED GRADED UNDER STATE SUPERVISION"

and the logo for the Pennsylvania Preferred program. Pennsylvania Preferred is a program run by the State Department of Agriculture to encourage buying Pennsylvania products within the state. Was this indicia just the Pennsylvania Preferred advertising or is it some kind of an egg revenue stamp?

As time passed I noticed that eggs I purchased in other stores may or may not have this marking on them. So I became more suspicious that it might indeed be an egg stamp.

The Pennsylvania Egg Certification is administered by the Department of Agriculture, Division of Plant and Animal Safety. It is described in detail by the state laws, Chapter 85, Subsection 85.1-85.6. This program was begun effective July 1, 1965. Egg inspection has been standardized in Pennsylvania since 1929.

The state does not inspect most eggs. Rather grading and candling is normally done by the producers, especially in smaller operations. Size grading is done in line with U.S Department of Agriculture standards, and quality grading using an AA, A and B grade system. State inspectors can pop in on you at any time (as can USDA inspectors) to make sure you are not cheating the public or selling bad eggs.

But the Certified Egg program gives producers the opportunity to mark there product as being given a higher level of inspection. It can be entered into by either a large scale producer or a distributor.

In this program, the Department of Agriculture trains and licenses inspectors and gives each organization a code (in the case of my egg box it is PA-149) which designates the organization doing the inspecting. With the trained personnel, the state then permits "the organization to use such insignia, stamps, labels or seals as may be adopted by the Department as official in the certification of eggs. The cost of such insignia, stamps, labels or seals shall be borne by the organization." That would be true if they were just adding advertising, so this does not make it a revenue stamp.

The trained inspectors then take over the job of inspecting the eggs. For efficiencies sake, the inspectors "may not be restricted to the performance of certification work only, but may discharge other duties which do not interfere with the certification work." So they can spend the rest of the day feeding chickens, or cleaning out the hen house, so long as they do the certification. An organization has to have at least two trained inspectors, in case one gets sick or goes on vacation.

The inspectors take required samples, and issue official certificates for the eggs, and file monthly reports to the state. When starting out, an organization is on a six month probationary period. The state does there own inspections and watches the reports to make sure everything is working as it should. When everything is working smooth, then you enter into the Certification agreement.

What the agreement states is that the "organization agrees to pay the Commonwealth of Pennsylvania for supervisory services in this certification program, the following fees:

So there are fees which support and pay for the program. At the low volume end on consumer eggs, the fees are running between 1 and 2 mills per dozen. The rates get much cheaper at higher production rates.

This fee schedule is not dissimilar to the fees paid for eggs stamps in other states. The price of stamps in Oklahoma, for example was 2 mills per stamp per dozen, or 2 mills per case stamp. The Florida case stamps (30 dozen eggs) were 4 cents, about the same as the rate for 500 cases a month (\$20.00).

My conclusion is that the keystone marking is indeed an egg stamp. You may draw your own conclusion.

Book Review

The Revenue Stamps of the State of Alabama, by John D. Bowman, 232 Leaf Lane, Alabaster, AL 35007, johndbowman@charter.net, Price \$25.

John Bowman has finally come out with his much anticipated work on the Alabama state revenues. However, John's work comes on a CD instead of in a book form. The book is in Adobe PDF files, one for each subject (example Beer, Feed, Fertilizer, etc.). Almost all the illustrations are in a color. Rather than hassle with trying to print it, he has left that for you to do if you wish. And if you do print it out (as I have done), be prepared to print about 100 pages.

The egg article in this issue is a good example of the books' content. Each section opens with a discussion of the laws and the history of the stamps. Then the stamps are illustrated. The illustrations are often excellent blow ups, and in the sections on beer and the tough to catalog feed, he shows many varients never before cataloged with useful blowups to illustrate the varieties.

The catalog has prices for the stamps, however, on most of the scarcer material, he has simply left the R (rare) indicator.

This catalog includes tax tags, vending machine decals (surprising how many are out there), and even has some of the municipal vending licenses. Duck stamps are not included, but boating licenses are shown and there is a short section called "Miscellaneous" with some scale seals and a fire extinguisher stamp. Trucker for hire, or "bingo" stamps are included through 1988 as are drug stamps, mineral documentaries, oleomargarine, and punchboard stamps.

John is still working on the Alabama municipal, city and state tax stamps.

Overall this is a fine piece of work and a must for serious collectors of Alabama material. Whether printed copies of catalogs or CD's like Bowman's are the wave of the future only you the consumer can decide.

As I started to organize the new finds, I began to doubt they were actually county issues, but merely state tax meters with the county names on them; perhaps a security feature?

I welcome your thoughts or further info regarding these issues. The question does remain - are these tax stamps county or state issues, or a combination of the two?!?!


My Thinking on Kent's **Ouestion**. by Scott Troutman

The question posed by Kent in the above article is one I have also hit doing the North Carolina, Oklahoma and now the "big catalog". The following is my current thinking.

In the case of North Carolina and Oklahoma we know the meters were provided by the state and the revenues went to the state. I suspect this is true in all these cases. The county clique showed which county the meter was used in. I might add, in some states there were also handstamps of a similar nature. For that reason, I am considering them state stamps. In some of the states, North Carolina being an example, it is not clear that all counties even used the meters.

In the big catalog, I will give them one listing for each design and sublistings for colors or tape differences. The county will be ignored.

I suggest in individual state catalogs all known need to be listed. Clearly a Pasquotank County, N.C. (rural county) saw less usage than Forsyth County (heavily populated). At the moment prices don't seem to reflect this except among state specialists.

Some of the hot lots were 47 CO DMV search (\$10 est/\$10.50 realized), 61 FL CF16 (\$35/\$52), 134 LA feed (\$4/\$5.25), 135 LA feed (\$2/\$3.25), 137 LA paris green (\$1.50/\$2.50), 138 La soft drink (\$2/ \$3.75), 188 MS cigar (\$1.50/\$2.25), 238 NM liquor (\$3.50/\$4.75), 352 VA import beer (\$2.50/\$4.00), 362 WA rhubarb (\$50/ \$52), and 364 WA wine (\$1.50/\$3.25).

Hot areas were beer, hodgepodges, PA county deed stamps, NC, MS, DC and LA with some good returns on MI trout. Lot 158 the MN title transfer brought (\$20/\$28). A lot of good fishing material didn't even get a nibble, and some good egg stamps and Utah beers went cheap. Best

buy was the rare PA beer on a \$325 US revenue that went for \$105.

Book Reviews

California Feed Tags with Tax Paid Indicia "Feeding Stuffs" by Joe Ross.

It is my distinct pleasure to announce the long, long overdue catalog on the feed tags of the state of California is now in print! As you may well know, if there is an area in state revenues that has been overlooked and just plain neglected it's tax tags. And the California tags are more varied than any other state, with the indicia handstamped and printed on a huge variety of feeds.

The publication is spiral bound, 60 pages in length and available in either color or black and white. The author has done a magnificent job of taking the reader step by step through the evolution of changes and myriad of issues that were in use over an expanse of almost 20 years. Joe, the recognized authority on this material, has also priced the tags as well!

The Colorado Kid, by Stephen King, NY: Dorchester Publishing Co. 2005, Paperback. 184pps. \$5.99

It will no doubt seem odd for a review of a work of fiction to be reviewed here, no less a work by Stephen King. But bear with me. This book is a bit of departure for King. It is not a horror novel. Rather, it is a well formed who-done-it set in, of course, Maine. Put simply, the story takes place in a restaurant where two elderly Maine newspapermen are telling their cute young female intern of one of the unsolved mysteries that took place in the small town where they publish the paper. As one who grew up in northern New Hampshire and spent time in Maine, the dialogue strikes me as dead on. It's a tribute to King's skill as a writer that he is so perfectly able to capture in dialogue both the taciturn and friendly nature of the true New England old timer. And for this not-yet-too-elderly new Englander, it's a delight to hear that dialogue again.

The mystery concerns a man found dead in the aforesaid small town. Who was he? Where did he come from? Why was he killed? These are all natural questions for any reporter to ponder and the two elderly gentleman have pondered on them long and hard over the years. Be warned--the ending will not satisfy everyone. But for those who love a good mystery and can stand ambiguity, this is a wonderful book. And don't be put off by the cover art--it has nothing to do with the story. Oh, and why is this book reviewed here? Because a state revenue stamp provides a major clue. Almost certainly a first in crime fiction.

Unreported Illinois Cigarette Stamps



Officially designated as a "Luxury Privilege Tax," Arizona's tax on controlled substances was enacted in 1983. Although over two dozen states eventually followed with drug tax laws of their own, Arizona's was first and, at least when it came to the tax rates, the most reasonable.

Most states have imposed an obviously punitive tax equal to or exceeding the street value of the taxed substance, with rates of \$3.50 or more per gram of marijuana and \$200 or more per gram for other controlled substances. Arizona, on the other hand, taxed marijuana at the rate of \$10 per ounce (\$.35 per gram) and other controlled substances at the rate of \$250 per ounce (\$8.80 per gram). Given these rates, even the \$100 annual license fee for dealers in marijuana and controlled substances, and the requirement that dealers purchase stamps in sheets of 50, were not so outrageous when compared with the tax rates of other states.

Yet, like most states, compliance with the drug tax remained low, with most sales to collectors. In the first 12 years the tax was in effect, only 21 licenses were sold.

That all changed, beginning in November, 1995. That is when an Arizona marijuana reform activist and co-founder the state chapter of the National Organization for the Reform of Marijuana Laws ("NORML") was arrested and charged with possession of marijuana. Because he had complied with the tax law and had his license and stamps, however, the magistrate held that the drug prosecution would constitute double jeopardy and dismissed the charges. Appeals by the state were unsuccessful.

Jumping into this perceived loophole in the state drug laws, and with no little encouragement from the state NORML chapter, others of like persuasion made a run on the Arizona licenses and stamps. Over the next 18 months, the state sold approximately 183 new licenses and quickly sold out its initial, 1983 printing of 20,000 1-gram marijuana stamps. The state ordered a new printing of both the 1gram stamps and the 1-ounce stamps, tax officials having determined remaining stocks of the original 1-ounce stamp to be so fragile as to be almost unusable. The new stamps were delivered around mid-1996.

Fearing that the increase in "legal" drug dealing would damage the state's image, Arizona legislators moved to repeal the tax. In doing so, however, they faced an unusual foe. NORML and other prolegalization folks initially opposed the repeal on the grounds that it was better to tax drugs than to criminalize them.

The repeal effort finally succeeded, however, when it became clear to those favoring legalization that the police and the courts were not following the first magistrate's view of the law. The bill repealing the drug tax was approved by the governor on April 28, 1997, and went into effect on July 21, 1997. On that date, the state department of revenue stopped selling the stamps and licenses.

Prior to repeal, Arizona issued a total of about 204 licenses and sold approximately 28,250 l-gram and 1,050 l-ounce Cannabis (i.e., marijuana) stamps. It sold between one and five 50stamp sheets of 1-gram controlled substance stamps at \$440 per sheet. It did not sell any of the 1-kilogram Cannabis stamps (at \$17,637 per sheet), the 1-ounce controlled substance stamps (at \$12,500 per sheet), or the 1-pound controlled substance stamps (at \$200,000 per sheet).

The original marijuana stamps and all of the controlled substance stamps were "water activated," perforated, and issued in numbered sheets of 50 stamps, 10 across and 5 down. The 1-gram and 1-ounce marijuana stamps are perforated 11 3/4. The original design represented the logo for the Arizona Department of Revenue at that time. The original 1-gram marijuana stamp is red, the 1-ounce is light blue, and the 1-gram controlled substance stamp is purple.

The artwork for the new printing of the 1-gram and 1-ounce marijuana stamps in 1996 was changed to a simple outline of a cactus, along with the denomination. These stamps were self-adhesive at the request of the Department's customers. The new stamps likewise were issued in numbered sheets of 50 stamps, 10 by 5, and roulette 9 1/2. The new 1-gram stamp is printed in purple, while the 1-ounce is light blue.

Last year's repeal of the drug tax law may not be the final chapter in this story, however. A few months before repealing the drug tax then in effect, the legislature had enacted a sweeping overhaul of the Arizona tax code. Under that enactment. the entire existing tax code is repealed effective January 1, 1999, and is replaced with a new code. See Arizona Laws 1997, Ch. 150. The drug tax is included in the new code which takes effect January 1. A.R.S. s.42-3001 et sec. (effective 1/1/99). The law which took effect on July 21, 1997, and repealed the drug tax law as it then existed, did not address the new code which takes effect on January 1, 1999. Unless the Arizona legislature acts, therefore, Arizona will be back in the business of selling licenses and tax stamps to drug dealers and collectors at the beginning of next year.



Nebraska Scale Seals by Scott Troutman

In 2005 a set of Nebraska scale seals appeared on Ebay. These are die cut self adhesives with a most unusual shape. The hole in the state apparently goes around the scale set screws which are normally covered by the scale seal. Three years have been seen with the following colors. I do not know if these were used on scales or gasolene pumps or both.



The 50 cent stamp has the value centered and shifted up. The \$1.00 stamp has the value shifted up and down, touching the border of the rectangle in both cases. The \$2.50 stamp has it centered, shifted up and touching the border, and shifted to the right. I have examples from other years. The possibility exists for several varieties for each denomination for each of the 11 years! It appears there is fertile ground for original research here.




Oklahoma Egg Variety by Michael Florer

This item was sent in by Mack Matesen and John Bowman. It is an Alabama 1/4ct feed F24 type from 1922. It has a typed overprint "PROVISIONAL/ 1927" in a purple ink. Their thinking is that this overprint is completely bogus. John's thinking is "no low-paid soul typed up a bunch of provisional ones, especially so nice spaced". The stamp doesn't have a date associated it with it, so what would be the point. There is no other tax in effect in 1927 that it could have paid.
