

portion of the stamp is concerned. Underneath the value is the inscription "Void after Dec. 31, 1963" and at the right of the map is an inscription "New/STATE/RECORD/FISH/AWARD," the significance of which we do not know. Can one of our readers enlighten us?

PENNSYLVANIA CIGARETTE TAX would be increased from 6¢ to 8¢ if a bill passed by the house goes through. Also in the mill is an increase of the sales tax from 4% to 5% which would make it the highest so far in any state. No stamps are involved in the sales tax, of course. Nothing certain on the cigarette tax as yet, either.

NEW YORK CITY - CIGARETTE TAX - This has been doubled to 40 a pack, effective June 1, 1963.

MINNESOTA CIGARETTE TAX - Since writing the first page of this number of the Newsletter, this increase from 7¢ to 8¢ a pack has been put into effect. The bill was approved May 20th and went into effect May 21, 1963. most of the nature and to drag

NEBRASKA - CIGARETTE TAX - Effective June 1, 1963, the rate of tax is increased from 4¢ to 6¢ a pack.

NEBRASKA - BEER AND ALCOHOLIC BEVERAGES - The tax on beer has been increased from 4g to 6g per gallon regardless of the alcoholic content.

faremum world ditw . suld 508 The tax on alcohol and spirits has gone from \$1.20 to \$1.60 per gallon.

FLORIDA LOCAL TAXES - There is pending in the legislature a bill which would grant counties the same power to impost and collect taxes as is granted to municipalities.

FLORIDA TAXES - PROPOSED CHANGES - Before the legislature, but not yet enacted and approved is a proposed tax of le on each 12 ounces of bottled or canned beverage not subject to the tax on alcoholic beverages. Also a proposal to raise the cigarette tax from 5¢ to 8¢ a pack. A proposal to increase malt beverage tax from 24¢ to 72¢ per gallon in bulk, and from 3¢ to $4\frac{1}{2}$ ¢ per half pint in containers is also before the legislature. A bill exempting Florida, its political subdivisions, and the United States from the documentary tax is also being considered. NEW JERSEY - effective May 31, 1963, increased the tax on cigarettes from 7¢ to 8¢ a pack. Swiss revenues are collected and swapped by SRS member Professor David M. Maynard, 12594 Knoll Drive, Los Altos, California. The good professor was a U. S. Consul for many years, which enabled him to put together an outstanding collection and trading stock of these stamps.

M. D. Joyce (ARA) who owns one of the finest U. S. State
Revenue collections, is in Beverly Hills again after many
years absence. He is researching U. S. battleship revenues
with printed cancels. Collectors interested in helping him

are among the five finest in existence.

OHIO - A 1¢ Columbian on plain orange paper has been found without serial number and without staple holes. These were issued in gummed-back pads of several hundred instead of stapled pads of 100. It is odd that they went unreported for many years, since the 1¢ is the most commonly used value.

LOUISIANA - The 5¢ blue Insecticide and Fungicide stamp has turned up in a vertical pair, one without "5 POUNDS."

NEW ORLEANS still uses city liquor tax stamps. These have always been elusive and desirable. Licensed dealers, only, may purchase the stamps.

NEBRASKA - A few 25 pound FEED stamps have turned up rouletted in error with the bottom line appearing at the top of the stamp.

NEW YORK - The vertical rectangle design stock transfer stamps on thick white paper have proven to be very scarce over the years, as have most of the Liquor, Mortgage Endorsement, and Investment Tax stamps. The last set of stock transfer stamps has been reported with several values released in horizontal pairs imperforate vertically.
