HERMANN, SRS-42, THE AMERICAN REVENUE ASSOCIATION HAS RECEIVED A LISTING OF THE LABELS USED BY THE VARIOUS BREWING COMPANIES IN PENNSYLVANIA DURING WORLD WAR II, ACCORDING TO AN ARTICLE IN THE OCTOBER ISSUE OF THE AMERICAN REVENUE. THESE HAVE THE STATE TAX MEDALLIONS PRINTED THEREON, ACCORDING TO MR. HERMANN, AND WERE USED BECAUSE OF THE SHORTAGE OF THE TAX CROWNS THAT HAD BEEN USED.

ALTHOUGH A LIMITED PRINTING, IT WOULD BE A VALUABLE AID TO THE COLLECTOR OF THIS SPECIALTY, AND ALSO TO MEMBERS OF THE SOCIETY WHO ARE ALSO ARA MEMBERS.

## Louisiana

### ALCOHOLIC BEVERAGE STAMPS DISCONTINUED

THE USE OF TAX STAMPS AS THE MEANS OF COLLECTING THE TAX ON ALCOHOLIC BEVERAGES WAS DISCONTINUED OCTOBER 5, 1964, ACCORDING TO NOTICE RECEIVED FROM THE BEVERAGE AND TOBACCO TAX DIVISION OF THE LOUISIANA DEPARTMENT OF REVENUE.

INVENTORIES OF UNUSED TAX STAMPS HELD BY DEALERS AND OUT-OF-STATE SUPPLIERS IS TO BE FILED. NO MENTION IS MADE OF FINAL DISPOSITION OF SURPLUS UNUSED STAMPS BY THE DEPARTMENT OF REVENUE, OR WHETHER THEY WILL BE MADE AVAILABLE TO REVENUE STAMP ENTHUSIASTS.

## In and Around Missouri

### MOTOR FUEL INSPECTION TAX

THE MOTOR FUEL TAX DIVISION OF THE MISSOURI DEPARTMENT OF REVENUE ISSUES TWO INSPECTION STAMPS ANNUALLY FOR EACH GASOLINE PUMP INSPECTED. THE 1964 STAMP, OF THE PRESSURE SENSITIVE DECAL TYPE, IS MULTICOLORED ORANGE, BLUE, BLACK AND WHITE, AND IS INSCRIBED "STATE OF MISSOURI/ DEPARTMENT OF REVENUE/ M. E. MORRIS, DIRECTOR/ THE MOTOR FUEL TAX DEPARTMENT/ INSPECTED AND APPROVED THIS PUMP". THIS INSCRIPTION IS FOLLOWED BY A VALIDATING SPACE, THEN BY A SERIAL NUMBER AND THE YEAR 1964. THESE STAMPS ARE AFFIXED, A PAIR, TO EACH GASOLINE PUMP IN THE STATE, AND VERY FEW HAVE FALLEN INTO THE HANDS OF COLLECTORS, AS THEY ARE APPLIED TO THE PUMP AT THE TIME OF INSPECTION, AND CAN NOT BE REMOVED AFTER A REGULATION YEAR'S DISPLAY WITHOUT DESTRUCTION OR MUTILATION, AND THEN ARE USUALLY FADED AND DAMAGED BY THE ELEMENTS OF MISSOURI'S COLD WINTERS AND HOT SUMMERS.
