

NEW JERSEY MAKES TROUT STAMPS AVAILABLE TO COLLECTORS

Under date of February 24th, the Department of Conservation and Economic Development of the State announces that collectors will have an opportunity to add the second issue (1954) to their collections. There are two denominations: a \$1.00 gray and black stamp for resident fishermen, and a \$5.00 green and yellow stamp for non-residents.

The stamps come in sheets of ten, each stamp in the sheet being fully perforated. Collectors may purchase them in single sets, blocks of four sets or in full sheet sets. The set of two stamps (\$1.00 and \$5.00 denominations) are offered at 50¢, blocks of four \$2.00, and in full sets of sheets at \$5.00. Remittances should be made by check or money order payable to the New Jersey Division of Fish and Game. Postage stamps cannot be accepted in payment because of accounting problems. Orders should be send to: Trout Stamps, Division of Fish and Game, 230 West State Street, Trenton 25, New Jersey.

All revenue received from the sale of these stamps is to be used for Fish and Game management.

The opportunity to secure this second issue of trout stamps in mint condition is limited to requests received before April 1, 1960. Present plans are to destroy any remainders of this limited issue after that date, as was done with the 1953 issue.

It is your publication and as such should serve as a clearing house for such things. Remember, what is "old hat" to you may be entirely new to a member in another state. We hope you will make use of it and would like your suggestions and help.

Although Alaska and Hawaii have been included in catalogs published covering state revenues, the Virgin Islands and Puerto Rico have been omitted, and your editor feels that they are equally entitled to representation. The latter, in particular, has a rather extensive range of issues. There are also some city emissions as well as a "tax paid" group - that is; cigarettes, liquor, etc. Several of these are illustrated on the cover. If it meets with your approval, the writer would like to list those he has or has information regarding, and have such listing corrected or added to by those who can.

Another neglected branch of state revenues is what might be called "stationery." This includes stamped paper and tax tags. One of the tags is shown on the cover. The late Mr. E. R. Vanderhoof told the writer that at the time the 1921 catalog was prepared, a list of these was made up, but was not included. He did not know what became of the manuscript for it. Is it still in existence somewhere? If so, could it be borrowed long enough to be put on record? The writer has found these to be of considerable interest and would like to see a list of them also.

SOUTH DAKOTA - GAME STAMPS issued in 1959 in 9 different values from \$2.00 to \$25.00. So far the \$25.00 in a design like that of 1949-1950 has been seen. -This from Mr. Frank Applegate.

- KENTUCKY LIQUOR stamps will become defunct at the end of March of this year in favor of the report system. The state tried this once before in 1955 but gave it up when it was realized that the budget would suffer a lag of from one to one and a half million dollars when advance sale of the stamps was discontinued. The plan now is for the brewer to remit an amount in advance which is double the average 1959 monthly purchases. - From "El" Hubbard.
- ARIZONA CIGARETTES and TOBACCO PRODUCTS. H. B. 164 proposes an increase as follows:

Cigarettes, per pack of 20, from 20 to 40. Smoking tobacco, snuff, fine cut chewing tobacco, cut and granulated tobacco, refuse, etc., except products used for agricultural purposes, from 10 to 20 per ounce or major fraction.

Cavendish, plug or twist tobacco from 1/4¢ to 1/2¢ per ounce or fraction.

Small cigars, each 20 or fractional part, weighing not over three pounds per thousand, from 2¢ to 4¢.

Cigars of other description made to retail at 5¢ or less each, from 1¢ per each three cigars to 2¢ per three cigars, and if made to sell at over 5¢ each, from 1¢ per each cigar to 2¢ per cigar.

UNITED STATES - DISTILLED SPIRITS stamps were discontinued in 1959. These were the green ones used on distillers' reports - which are never supposed to reach stamp collectors, but do. - From Mr. Hubbard.
