BALTIMORE, MARYLAND - The city pressure sensitive issue, CR17-19 are not for cigars only. They cover all tobacco products except cigarettes. The cigarette tax is collected for the city by the State. Additional values in this series are: 1¢ pink, 2¢ yellow, 3¢ blue, 4¢ dark brown, 5¢ red, 6¢ purple, 12¢ orange, 15¢ gray. These were introduced in 1962 and come 500 per roll. What seems to be a die variety is found on the 3¢. There is a white space that is just to the left of the "3¢" in the lower right corner. Our illustration may not show up; the listed 50¢ is shown for comparison. Thanks to Terry Hines for this information.

CANCELLATIONS ON THE NEW YORK
SECURED DEBT TAX STAMPS

Kenneth P. Pruess

The Secured Debt Tax Stamps of New York constitute an attractive set which has long been popular with collectors. While not overly abundant, the stamps are well known. No minor varieties worth mentioning have been discovered in the stamps themselves; yet this set affords ample opportunity for specialization.

Israel Mundicipals, and much more. Kenyon, in his classic volume of 1920, "Documentary State Revenue Stamps of the United States", adequately reviews the laws pertaining to usage of these stamps and makes mention of the cancels to be found on them. The purpose of this article is to provide further details on these cancels and clarify the information given by Kenyon. Recognizing that few readers will have either the stamps or inclination to proceed with the study, I have chosen to describe only the major variations; lesser variants may be found among all types. Manuscript initials are generally excluded

though they should be considered by anyone continuing the study. There is good evidence that each minor variety is associated with a different authorized agent of the Comptroller.

EMBOSSED CANCELS - Throughout the period these stamps were used, all were cancelled with a seal having "STATE OF NEW YORK · TAX ON SECURED DEBTS" in a beaded circle and "PAID" in the center. Several varieties occur, differing in overall size and spacing of letters. This seal was used in addition to the ink cancels described below.

INK CANCELS - These are best classified by the dates between which each type was used.



First issued for 1963 season. Leaping German Brown
Trout with artificial fly in mouth on all issues through 1968. Overall size approx 54 x 45 mm 1963 through 1968. 1963 through 1966 stamps from panes of 10 (2 x 5) with perforated selvage all four sides.





- 1963 \$1 black and green on white. Perf 11 3/4. Green serial number.
- 1964 \$1 black and dark blue on light blue, dark blue serial number. Void date inscription enlarged, otherwise same as 1963.
- \$1 black on light yellow. Black serial number. Otherwise same 1965 as 1964.
- 1966 \$1 reddish brown and black on white. Black serial number. Changes in printed text, otherwise same as 1964.
- \$1 reddish brown and black on green. Black serial number. Otherwise same as 1966 except from panes of 10 (2 x 5) imperforate at right and left and believed to be imperforate at bottom. Perforated selvage of approximately 27 mm at top of each pane has printed inscription indicating serial numbers on that pane. Example: No. 34711 TO NO. 34720.
- 1968 \$1 violet and black on white. Black serial number. Otherwise same as 1967. From panes of 10 (2  $\times$  5) believed to be similar to 1967 issue. similar to 1967 issue.

## Big Game Hunting Stamps (For Archers Only)

First issued for 1960-61 season. All issues 1960-61 through 1966-67 are from panes of 10 (2 x 5) with perforated or rouletted selvage all four sides.

Overall stamp sizes approximately 54 x 45 mm. No serial numbers prior to the 1962-63 issue. Discontinued after 1967-68 season and superseded by \$5.50 Deer and Turkey stamp for either Firearms or Bow and Arrow hunting.



- 1960-61 \$3 reddish brown and green on white. Design: Bow and arrow superposed on running buck whitetailed deer.

  - 1963-64 \$3 black and brownish red on white. New design, standing buck whitetailed deer. Perf 11 3/4. Brownish red serial number.
  - 1964-65 \$3 black on green. Otherwise same as 1963-64.



No serial numbers prior to the 1962-63 issue. Discontinued after 1967-68 season and superseded by \$5.50 Deer and Turkey stamp for either Firearms or Bow and Arrow hunting.



MAINE DOCUMENTARY -Maine uses a very attractive Pitney-Bowes meter. During January and February 1968, before the P.B. meters were delivered, the State used stamps. There were five values, all on yellow paper: 55¢ black, \$1.10 blue, \$5.50 green, \$11.00 red, and \$55 brown.


Stamps are commonly found with additional manuscript initials.

Jan. 1, 1917 - May 31, 1917. In his book, Kenyon records a cancel like the preceding, but with space for number of years left blank, this to be filled in by hand. I have never seen this cancel and there is reason to doubt its existence simply because the law did not provide for use of stamps during this 5-month period. If such a cancel exists, it is certainly scarce.


WASHINGTON CHANGES TO FUSION CIGARETTE STAMPS - In Washington State all licensed distributors must stamp cigarette packages with a heat-applied fusiontype stamp instead of stamping with ink impression meters beginning on Dec. 1, 1968. The meter impressions are often illegible which makes discovery of counterfeit meter stamps nearly impossible. There are no known cases of counterfeiting in the use of fusion-type stamps.

George Kinnear, director of the Department of Revenue, states "from reports of my staff I believe illegibility may run one-third or up to 100 million impressions a year." Kinnear said with meter impressions there have been extensive cases of counterfeiting throughout the country, especially in New York State with four known cases in this state. "The use of the fusiontype stamp will insure against a potential loss of state revenues through counterfeiting", Kinnear said. The use of fusion stamps will possibly increase revenues by \$2 million per biennium, based on statistics provided by the National Tobacco Tax Council.
