#### DESIGN DIFFERENCES ON NEW HAMPSHIRE STATE SEAL DESIGN DECALS

In addition to the differences in size, card, safety, etc. there are also distinct design differences between decals of the same denomination in the clear (T142-148) and blurred (T149-165) series of New Hampshire state seal design decals. The differences are in the value numeral and are illustrated in the following figures. Hubbard, Charles

- Figure 1: 1/2¢ (T142 and T149). T142 has serifs on the "1" and "2" which are absent on T149. The fraction bar is curved on T142 and straight on T149. Both numerals and bar are thicker on T142.
- Figure 2: 1 1/2¢ (T143 and T150). The numerals are somewhat thicker on T143. The serif on the first "l" is sharper on T143.
- Figure 3: 2¢ (T144 and T151). T144 is shown; T151 was not available for comparison.
- Figure 4: 2 1/2¢ (T145 and T153). The major T142 T149 difference on the 2 1/2¢ is the presence of a serif on the tip of the first "2" on T145.
- Figure 5: 3¢ (T146 and T154). There are serifs The enterior in on the "3" on T146 that are absent and Lock lot on T154. of noise



# OHIO'S PRIVATE-ISSUE SALES TAX CARDS Jerry F. Schimmel, SRS #209

Most State Revenue Society members are familiar enough with the Prepaid Sales Tax Receipts (or stamps) issued by the State of Ohio. A few know something about the grey, and later orange, state-issued Prepaid Sales Tax Cards. But one of the least known series associated with Ohio's sales tax collection methods were the private tax cards of 1935. The sales tax law had come into being on January 27 of that year and with it the Prepaid Sales Tax Receipts. The receipts served the state an excellent function of, 1) being insurance that the state would have some money right away as the merchants had to purchase them in advance of the tax actually being collected from the consumer; and 2) by providing the consumer and the state with a receipt for the sales tax that he had paid. This prevented any unscrupulous merchant from accepting the sales tax and not reporting it, as he had to account for the money with the stubs (Vendor's halves) to the state auditor. What happened if the consumer did not bother to accept his receipt is probably another story.

However, the cards served another purpose. They were, in effect, Ohio's "sales tax tokens". That is, they were designed specifically to assist the consumer in paying any fractional sales tax that might be due in a transaction, and to avoid making a sales tax overpayment. For example a customer might wish to buy a 10¢ toothbrush, but since the sales tax at that time was 3% of the purchase price, the tax due would have been 1/3¢ or 3 1/3 mills for which amount there was no U.S. coin in circulation. The customer and merchant were then faced with the prospect of a sales tax payment at a rate of 10% if the customer paid a whole penny. This usually meant that the merchant kept the other six and two-thirds mills for himself. Merchants, consumers, and law-makers, by 1935, had become somewhat sensitive to the overpayment issue, hence the use of Sales Tax Cards in Ohio and tokens in other states. Thus, each card was purchased by the consumer from the merchant for three cents which amounted to an advance payment of tax on one dollar's future purchases. The card had a number of spaces with denominations in them which added up to 100 (or \$1.00). Therefore in the case of the man with the 10¢ toothbrush, the clerk simply punched a "10" or two "5"s and there was no overcharge and everybody was theoretically happy. The customer would retain his card, if there were remaining spaces unpunched, for another day's use, or for a purchase

at another counter in the same store. When they were completely punched, they were returned to the store and became the merchant's receipt for the state.

The private cards were usually printed at the merchant's expense and were validated by gluing on the reverse a pair of 3¢ tax receipts in the space designated. This is probably the only instance where the Ohio Receipts were used genuinely as an adhesive documentary stamp. The card had a stub which was retained by the merchant and dated at the time of sale. In size they were  $5\frac{1}{4}$  by  $2\frac{1}{2}$  inches (with stub), and were usually white, although many are now faded to light brown or buff. Ink color was usually blue or black. An intresting sidelight is that one firm, the Serv-Ice Delivery Company of Akron used a tear coupon form. That is, instead of spaces being punched out there were coupons to be torn off for each tax payment. The Vendor's stub had the Receipt halves attached to its reverse and the customer's portion had its corresponding halves affixed. The \$2.00 card mentioned in the list below from Phil's Market in Cincinnati was actually a credit punch card with the sales tax included. That is, the customer paid the merchant \$2.06, and then brought the card back with which to make his daily purchases. In this case the tax was prepaid, but so was part of his grocery bill.

The list below is considered to be incomplete as there is considerable evidence that other cards were issued. If any readers have items like this or know of their whereabouts that are not listed here, I would appreciate hearing from them about it, as I am continuing work on a catalog of sales tax items. 

#### 1907-11 Issues

No plate varieties have been discovered to date on higher values.

The 20¢ has been discovered in greenish-black with violet overprint which is not listed.

An imperf copy of the \$2.00 green is known on the rough, yellowish paper with strawlike inclusions which was used on the second 1905 issue. Obviously this is a trial impression as there is black printing on the back and ink on the face and it does not have any overprinted numerals. No used stamps of this issue have been seen on this paper.

# 1914-15 Issues

The 1914-15 stamps are the same design as 1907-11 but are in new colors and the overprint changed to a solid numeral enclosed in a frame. The stamps appear to be from new or reentered plates which would account for the numerous double transfers.




Fig. 44. Second 1914 issue with dot added upper left corner (top), and third 1914 issue with dots added in both upper corners (bottom).

The second 1914 issue has a solid dot in the upper left corner while the third 1914 issue has dots in both upper corners (Fig. 44). These dots vary slightly on each stamp in the sheet.

There is another dot variety which has not been listed. This seems to occur only in the 10th vertical row - a smeary dot joining inner frame lines below upper left rosette. This variety is known on the 2¢, 10¢, \$1, and \$2.




Fig. 45.- Double transfer in upper left corner on 2¢ (ST60, 69, 75).

TEXAS DOVE - Texas has now joined the ranks of States issuing hunting stamps with a dove stamp issued in 1971. This is also the first confirmed stamp issued for this purpose. The stamp in printed in light and dark brown, grey lettering at top and year, value, and shading on dove in black. Serial number is also in black. This stamp is available to collectors but details are unknown. We would suggest writing the Texas Parks and Wildlife Dept., Austin, Texas 78711.
