WASHINGTON APPLE ADVERTISING STAMPS: VARIANTS OF THE 1937 ISSUE

M. E. Matesen

The monocolored 1937 issue of the Washington Apple Advertising stamps would at first glance give you the impression that they were all the same with deviations from the norm seemingly the exception rather than the rule. Probably the most striking feature to first catch one's eye would be the varied paper types and border thicknesses and certainly the shades within the single-color issues. But a closer in depth study would provide even more. BLANT TO PHON - CO.IS

"Washington Apple Stamps, Third Issue, A study by El Hubbard" provided a fairly extensive compilation of these stamps as to papers, colors and border

thicknesses, but yet touches slightly upon the variants that can be found. The consistence of these is pointed out by the fact that they appear on all the paper types over the period of time they were in use and in some instances appear in the same position location in relation to the sheet make-up. They were printed in sheets of 20 (4 x 5), straight edge on all sides with a selvage at the left side, bearing a sheet number in the color of the stamp at top. (Figure 2)








Figure 3 Figure 4

Out of some 100 blocks examined, this variant occurred about 40% of the time in the same positions. This variant also appears in combination with other listed variants.
- Common to 1¢, 5¢, 50¢ and \$1.00 -Double break State seal center. first is at the base of the inner circle between "THE" and "STATE",





Fig. 51.- Double transfer at top and upper left, in "STOCK", and in "CENTS" on 10¢ (ST62).




Fig. 53.- Double transfer in "O" of both "10s", lower left of central circle, and at bottom on 10¢ (ST62) (Cont. page 14) cens, "house" tokens, foreign

TENNESSEE LIQUOR SEALS

Although previously reported as being discontinued, the State has retained the use of one type of stamp. This is a small water transfer decal with a white background and red lettering, center perforated internally in an oval.

This decal replaced a series which were identical with the exception of background colors. The control numbers on each was in black. The background colors of each are as follows: green, red, and black, the latter being replaced by the red and white decal mentioned above. All of these have the circle in the center blackened out. The product is Mos could be the blackened out.

Prior to the issuance of the above series, the state used decals that were identical with the exception that the circle in the center of the state map (which was blackened out on the above) had the unit type such as "1/5", "4/5", "1 gal", etc. inscribed. The only one of these I have seen is the 1/5 gallon

which was in light violet. No doubt a different color was used for each type, though I am unable to confirm this.

NEW WASHINGTON HUNTING STAMPS - Van reports that Washington issued two hunting stamps for 1971: (1) \$2 Upland Bird (required to hunt pheasant, quail or partridge). 76 x 51 mm. Design is cock pheasant in flight. (2) \$7.50 Archery and/or Muzzle loading Rifle Hunting. Details not available yet.

The following Constitution has been drafted by the present officers and governing board and is submitted at this time for comments. PROPOSED CONSTITUTION

Article 1 - NAME. The society shall be called THE STATE REVENUE SOCIETY. "SRS" shall be the official abbreviation.

Article 2 - PURPOSES. To organize those interested in stamps issued by States of the United States, and their subdivisions; and to promote the collection and study of those stamps; to record them and their history.

Article 3 - MEMBERSHIP. Members shall be ordinary members of good character who are interested in this aspect of philately. by November 10, to be return

> Applicants for membership must apply on a form such as may from time to time be agreed upon by the Board of Directors.

Names of applicants shall be published in the Newsletter and, receiving no objections within 30 days of date of publication, become members. Merit of objections to be passed on by the Board of Governors.

Dues are based on a calendar year, and become due on the first day of January each year. Such dues shall be \$2.00 per year (subject to change by Board of Governors if felt necessary) for all members.

Nonpayment of dues shall be cause for expulsion from the Society.

The Board of Governors shall select the Honorary members.

The President shall guide the Society and be Chairman of the Board of Governors.

The Vice President shall perform such duties as the President may delegate, and assume duties of the President if the President is unable to fulfill his duties.

The Secretary-Treasurer shall receive and send out official correspondence at the direction of the President or Board of Governors and shall keep a record of the membership, receive and disburse the Society's funds. The offices may be separated if necessary.

The Board of Governors shall consist of the President, Vice President,

Secretary-Treasurer, Editor, the immediate past President, and two other elected members.

The Board of Governors shall appoint officers to fill vacancies until an election is held, and may appoint such other officers as Librarian, Attorney, Sales Manager, or Representatives, who will hold office until replaced by new appointees. The Editor also shall be chosen by the Board of - 17 -

Governors. All expenditures shall be approved by the Board of Governors. The Board of Governors shall have full authority over conduct of membership, officers, and all official business of the Society. governing board and is sub

Article 5 - ELECTIONS. Elections shall be held every two years, not later than November of the year prior to the expiration of the officer's terms.

Terms of office shall start on February 1st; so that the January Newsletter may publish results of election certification prior to officers taking office.

Nominations shall be asked for in the Newsletter not later than September.

The Board of Governors shall recommend a slate of elective officers. Additional nominations for officers may be made to the Secretary in writing any time prior to October 15th, by any member in good standing, subject to the approval of the person nominated with the endorsement of three other members in good standing.

Ballots shall be prepared and mailed to all members in good standing by November 10, to be returned within thirty days. Ballots received after that time shall not be counted.

Ballots shall provide a writein space.

Voting - Each member in good standing shall have one vote for each office to be filled. The candidate having the most votes shall be elected.

Article 6 - PUBLICATIONS. The official publication shall be a periodical known as "The State Revenue Newsletter", to be published at intervals as decided by the Board of Governors. Other publications, books, or catalogs may be published from time to time as the Board of Governors decide. The Editor shall be in immediate charge of all publications.

Article 7 - AMENDMENTS. Amendments to this Constitution may be made from time to time when approved by the Board of Governors and ratified by the full membership at the time of elections.

Article 8 - RATIFICATION. This Constitution as suggested by the Board of Governors shall be approved by a simple majority of the voting members.
